GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law: The historically known system of God’s law all the way back to and including the Magna Carta and it’s associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

- I. Today's topic was a real-time testimonial interview with a woman describing her experiences related to vaccine shedding coming out of the CV-19 mandates.

Sherry provided evidence of her data analysis of the blizzard of documents given by public officials in response to public records requests for information from the Clermont County Board of Health. The focus of this research manifested in illuminating the massive grants public officials were provided for their cooperative participation in “the mandates.” It was clear that the sole motivating factor as far as public officials and agencies were concerned was how to grant themselves tens of thousands of dollars per each official, sometimes more. Lengthy discussion was had.

Beverly specifically suggests that all participants and those reading the minutes and watching the video after the fact request the grant detail reports between February 2020 to date, similar to those reports requested and analyzed by Sherry in Clermont County.

Michael reiterates the remarks by Dan Duvall that those of us who are self-tasked with “doing the right thing” by the rest of mankind must always stay aware that this battle is against spiritual principalities as much as it is a moral/ethical fight.

Kat illuminates the structural power-hierarchy within the counties that the Coroner is the only one who can call the Sheriff on the carpet, and the Clerk of Courts answers to the Sheriff, and down the line. The Sheriff Mack Constitutional inquiry survey needs to be re-written in such a way to address the man or the woman AND be inclusive of all men/women in these three elected office positions.
