Ross states our mission.

The Ohio State Jural Assembly is a never-for-profit, private membership association. Open Old Business –

Reports of officers - Treasury – Keith – there was an expenditure of \$40.81 for the OSJA banner for use at Flag Day in Lancaster this coming Saturday (June 14, 2025). Keith also finalized the funding for our participation in Saturday's celebration by donating the remaining \$55. Anyone interested in reimbursing Keith for either expenditure should kindly hand him cash face-to-face.

Education Committee Chair – Michael – Further discussion of the Ecclesia group and how to best govern in honor is discussed. C2K report on YouTube is a good resource for research. Cristina requests that Michael provide a brief summary tying together the mission of OSJA with the teachings of the Ecclesia group so that can be posted on the website with a link to their teachings.

Public Affairs Committee Chair – Cristina yields to the stated agenda topics and those members on the call for their firsthand remarks. Ross opens the topic for general assembly consideration: as the Grand Jury grows, the need for a ‘victims advocate’ acting in an intake review function to perform triage when potential claims come to the assembly is becoming more pressing. As grand jury commissioner, Beverly has been handling many of the initial interviews, with various other members discussing possible claims or notice processes with a variety of men and women – both members and non-members. Concerns are voiced over refraining from infringing on the sovereignty of man and woman coming to the Grand Jury as well as the very real possibility that some who seek our assistance may not be embracing our stated covenant goals of existing in peace, eliminating controversy and restoring honor at all times. Kat reinforces the idea that claims should not be coming to Grand Jury review until after the man/woman presenting their evidence has fully exercised all options within the *law of mankind* common law Notice process with no satisfactory remedy. The assembly concurs. ‘Intake reviewer’ needs to be proficient in coaching possible claimants through this process before sending them on to the Grand Jury Commissioner for determination on how to best proceed with their claim.

The critical idea of educating sheriffs/clerks of court/coroners on their responsibilities under common law so that we have the constitutionally guaranteed support in enforcing our grand jury verdicts is once again discussed. Please see recording.

Special Committee – Grand Jury Commission – As Beverly is not present this evening, Keith updates on the progress of his claim against Lancaster/Fairfield County Board of Health. See recording.

– *Job descriptions* – Ross reiterates that it seems the best way to get through the update on the job descriptions is for each officer/chair to write out what they do on behalf of the assembly so that if there needs to be a redistribution of responsibilities, it is openly presented and each sovereign man and woman within the assembly can consider and opine.
