Public Affairs – Cristina discusses

1. Joe Senk need for assistance in writing notices; Ross pushes the topic to a later point in the meeting.
 2. Keith new found major discrepancy in the way the Fairfield County Auditor is re-valuing properties at 60+% higher per year while her own property has only increased just over 8% in value over almost three decades. Discussion is had. ***Please see recording.***
 3. She then yields her update of Statewide activities to those members on the call who elect to report on their own county's activities. ***See recording.***
- Special Committee Report - Grand Jury Commission update (Beverly is not present this evening to give GJ report). – Keith updates on his claim and Grand Jury activities. ***See recording.***

- e. Joe Senk ongoing claim – Cristina updates the Assembly (again) on the history of his claim; discussion is had. Offers from multiple assembly members to assist Joe in writing Notices. This offer will be relayed to Joe. When names of each man/woman responsible within Summit County for continuing this elder abuse are located by Cristina, Public Affairs will update.
