GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these 'minutes' act as the active component of the Ohio State Jural Assembly jurist training 'handbook' by application(s).

**Common Law:** The historically known system of God's law all the way back to and including the Magna Carta and it's associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

**Peer:** one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

It is agreed by consensus that the goal is for this GJC to establish a general pattern of behavior for all men and women to reference and customize for use in their own claims. Each man and woman will choose to communicate in a slightly different manner, as each claim / harm / trespass are unique in and of themselves.

I. Today's topic was a deep dive discussion on the ways that claimants must be clear in their communications to stay out of the opposing jurisdiction while educating those men and women to whom we correspond.

Lengthy discussion was had. It was concluded that Keith should respond to the letter from "Constituent Services" by thanking the three officials listed on the letterhead for acknowledging both receipt of our NOTICE communication(s) and that we are addressing them as living men under the law, not as corporate entities under the jurisdiction of the ORC. The handwritten envelope to return the State BOH is proof that a living man or woman has received, understands and NOT rebutting the Notice.

Reminder that each man/woman who did present evidence in this claim should kindly complete their own (3 sentence maximum) summary for inclusion in the final presentment; assignments on the remainder will be forthcoming via email from Beverly.

**Conclusion:** Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day embracing to the general population.
