This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

**Common Law:** The historically known system of God’s law all the way back to and including the Magna Carta and it’s associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

**Peer:** one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

- I. Today's topic was the testimony of a police officer on his experiences with CV-19 vaccine shedding, specifically his observations of those who accepted the injection, beginning immediately as well as sustained changes.
- Questions and answers revolved around the psychological & personal interaction changes and the challenges they present.

II. Update on the Fairfield County Board of Health (Ohio Board of Health) claim process, notices, and future actions. Keith emphasized for the public record his desire to document his intent to place any and all equitable remedy monies into a secured form of Trust account designed to fund a holistic healing center in his County. This document is being formulated and will be discussed again in future meetings.

Beverly and Keith go over the draft letter to the Fairfield County Hall of Justice requesting a man or woman with competent knowledge of Common Law Magistrate responsibilities and conduct to be seated and confirm the claim which the OSJA GJ BoR (Petit Jury) has verified. *See recording.*

Based on the recent Executive Order #14288, the idea is revisited to contact the US Attorney General, National Guard, US Marshall, State Attorney General, Coroner and Sheriff responsible for Fairfield County, Ohio.

*Reminder that each man/woman who did present evidence in this claim should kindly complete their own (3 sentence maximum) summary for inclusion in the final presentment; assignments on the remainder will be forthcoming via email from Beverly.*

**Conclusion:** Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day embraceable to the general population.
