**GOAL:** exist in peace, eliminate controversy, restore honor, operate wholly in the private.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

**Common Law:** The historically known system of God’s law all the way back to and including the Magna Carta and it’s associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

**Peer:** one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

Michael highlights the importance of ensuring that as we request Magistrates, we vet those men/women to a degree that they understand we are not ceding jurisdiction, but instead they are acting as a man/woman who happens to have the specific knowledge and skills required to be seated as Common Law Grand Jury proceeding Magistrate.

- III. Discussion is had regarding other groups who have previously been organized and interested in accomplishing this same de jure goal within both Ohio and other states.

**Key Question “Who Certifies Grand Juries” – John Darash apparently has sent supplications to the US Supreme Court, President Trump and Pam Bondi’s office.**

**Conclusion:** Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day embraceable to the general population.
