This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

*The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.*

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

**Common Law:** The historically known system of God’s law all the way back to and including the Magna Carta and it’s associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

**Peer:** one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

I. Today, the GJC heard testimony from Tish, a 62-year old woman. Tish states she was a lifelong athlete with excellent health and superior recovery capacity until she accepted the CV-19 protocol in February and March 2020. Thereafter she experienced and immediate and dramatic plummet in her physical capabilities.

i. Tish shared with the GJ her letter to her Hamilton County Health Commissioner, which was discussed at length.

Several jurists expressed our gratitude for this sharing of harrowing and disappointing life occurrence(s).

Please see the recording for perspectives and recommendations both to and by Ms. Marquardt on her claim of trespass harm against the Commissioner of her local county Board of Health regarding the permanent life changes and difficulties stemming from her having been (what she asserts is willful) misinformed by her local county health department on vaccines.

II. Discussion is had amongst most participants on the call regarding the challenging social aspects of those who have clearly been harmed and is willing to stand in defense of their own health and well being.

III. Setting a date for a 15-person *petit jury* excluding the claimant and the GJ Commissioner (as they were included in the Board of Review claim verification procedure) was discussed.

**Conclusion:** Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of jurial participation less complicated/more modern-day comprehensible to the general
