GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

THESE MEETINGS ARE NON-POLITICAL, NOT RESTRICTED TO MEMBERS OF ANY SPECIFIC ORGANIZATION OR RELIGION; CONTINUITY OF EXISTENCE FOR THE LAWFULLY DE JURED OHIO STATE JURAL ASSEMBLY IS A SECONDARY FOCUS.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these 'minutes' act as the active component of the Ohio State Jural Assembly jurist training 'handbook' by application(s).

Common Law: The historically known system of God's law all the way back to and including the Magna Carta and it's associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

The options given to these recipients for ways they can achieve remedy and return themselves to honor is discussed.

- II. Beverly discusses her letter to Sheriff Alex Lape requesting his assistance in getting Keith's access to a proper court, and that no magistrate responds. Overarching ramifications are discussed.
- III. Including the Federal and Ohio state attorney general in this process is discussed.
- IV. The recent Clermont County Committee of Safety meeting is discussed. At least one new potential Grand Jury member is expected to join us soon.
- V. Recruitment is discussed, for the jural assembly and for the grand jury. Education on every level is crucial.
- VI. The OSJA (06/14/25) outreach project our presence at the Lancaster Flag Day celebration, is discussed.

FOOTNOTE 1: The Ohio Public Health Advisory Board is a state-level body established under Ohio Revised Code Chapter 3701, created to advise the Director of Health on public health matters. The board consists of members appointed by the Director of Health from individuals not employed by the state, including a physician, a registered nurse, and three public members (two representing entities licensed by the Department of Health or boards of health). Additional members are appointed by various professional associations, such as the Association of Ohio Health Commissioners, the Ohio Public Health Association, the Ohio Environmental Health Association, the Ohio Association of Boards of Health, the Ohio Society for Public Health Education, and the Ohio Hospital Association. The Director of Health or their designee serves as an ex officio, nonvoting member.

The board's primary responsibilities include reviewing and making recommendations on proposed rules under Chapters 3701 and 3717 of the Administrative Code, prescribing fees for services provided by the Office of Vital Statistics and the Bureau of Environmental Health, reviewing proposed policy changes for the WIC program, and addressing other public health issues at the state or local level as requested by the Director. The board must provide recommendations on proposed rules within sixty days of receiving them, and the Director must consider these recommendations before filing the rule, though the Director may proceed if the board fails to act. The board may also contact the Joint Committee on Agency Rule Review or

the Common Sense Initiative Office if it believes a proposed rule does not comply with established requirements.

The board meets at least four times per year, with a majority constituting a quorum, and may use video teleconferencing systems for meetings, allowing remote members to count toward quorum and vote if public attendance is permitted at a designated location. Members are expected to attend a majority of meetings, and unexcused absences from three consecutive meetings are considered notice of intent to resign. The Department of Health provides meeting space, staff, and administrative support, including an electronic web-based database for board documents such as agendas, minutes, proposed rules, and public comments. Members serve without compensation but may be reimbursed for necessary expenses and are required to attend annual ethics training.

The board annually selects a chairperson and vice-chairperson, and the Director designates a nonvoting secretary. The board may adopt its own bylaws and appoint subcommittees as needed. The Ohio Public Health Advisory Board operates under specific exemptions from certain state ethics and compensation laws, including sections 101.82 to 101.87 of the Revised Code.
