This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these 'minutes' act as the active component of the Ohio State Jural Assembly jurist training 'handbook' by application(s).

Common Law: The historically known system of God's law all the way back to and including the Magna Carta and it's associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

- I. This morning's conversation began with the discussion that the letter of request for assistance being sent to Pamela Bondi, the US Attorney General..
 - 1. It is specifically noted that the Fairfield County clerk of courts, Brendan Meyers, is in trespass against Keith for refusing to grant access to a courtroom with proper magistrate.
 - 2. Inquiry to Ms. Bondi includes reference to EO 14288 to hold local officials accountable to complete their responsibilities under the Constitution.
 - 3. Discussion is had regarding The Rules Enabling Act of 1934.

Described as: "The Rules Enabling Act of 1934 is a United States federal law that granted the Supreme Court of the United States the authority to create and publish general rules of practice and procedure for the federal courts. This act, passed by the 73rd United States Congress and enacted on June 19, 1934, repealed the long-standing "conformity principle," which had required federal courts to follow the procedural rules of the state in which they were located. The primary purpose was to standardize procedures across all federal courts, promoting consistency and efficiency in civil and criminal proceedings.

The Act authorizes the Supreme Court to prescribe rules governing the conduct of federal courts, including the Federal Rules of Civil Procedure, the Federal Rules of Criminal Procedure, and the Federal Rules of Evidence. However, the Act includes a critical limitation: the rules created cannot "abridge, modify, or enlarge any of the substantive right" of a party involved in a case. This means the judiciary cannot use procedural rules to alter fundamental legal rights, such as the right to a jury trial. The Supreme Court's rulemaking power is subject to congressional review and the ability to reject any rule adopted by the Court, which has led to a reduction in the Act's importance in recent years, particularly after Congress intervened in the 1973 adoption of the Federal Rules of Evidence.

The rulemaking process is carried out by the Committee on Rules of Practice and Procedure, known as the "Standing Committee," and its advisory committees, which are part of the Judicial Conference of the United States, the policy-making body for the federal judiciary. The Act is often described as a treaty between Congress and the judiciary, representing a key aspect of the separation of powers, where Congress delegated the essential rulemaking function to the judicial branch while retaining oversight authority." This act is how common law (Article II) courts were removed from America and replaced with Article III code/statute BAR legal courts.
