GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law: The historically known system of God’s law all the way back to and including the Magna Carta and it’s associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

- I. Obtaining a correct and true passport. Beverly discusses the process she has effectively used to get a true passport as a live woman on the land instead of being forced to relinquish God-given rights.
- II. Process of and reasons for unregistering as a voter.
- III. Verification of Beverly's claim(s) on Clermont County by the call participants, Grand Jury members, acting as a Board of Review.
- IV. Beverly calls participants to attend the Sovereign's Way leadership call next week at this same time. Details of the uniqueness of OSJA's requests to American courts are discussed, a plea to John Little and Greg Paul to guide us with substantive suggestions.
- V. Conversation is had regarding a professional debt collector (Louis) who utilizes currently available courts to gain remedy through claims up to \$75,000 each; it is concluded that a small committee will meet later today to all get on the same page as far as the questions/guidance/documentation we will seek from this man who is only going to give us one hour of his time at a \$100 fee before that meeting is scheduled.

Conclusion: Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day comprehensible to the general population.
