GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law: The historically known system of God’s law all the way back to and including the Magna Carta and it’s associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

The jurists who verified Keith's claim are requested to briefly document the personal experience of each man/woman by making a written statement supporting our credibility as his peers through firsthand knowledge of shedding and/or vaxx injury. Judy reads hers aloud as an example. Others are inspired and lengthy detailed discussion ensues. See recording.
- III. Aron Tutt, retired police officer living in Indiana who has spoken during our meetings in the past. He wrote an article on social manipulation through psy ops that is shared with the group. The concepts he presents are discussed at length. Please see recording.
- IV. Kat suggests that we locate the previous subcommittee within the Senate who held hearings several years ago on the matters we discuss; the ramifications of going to the existing system to get codes passed and implemented is reviewed.
