This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law: The historically known system of God’s law all the way back to and including the Magna Carta and it’s associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

Today's Topics

- I. Beverly shares the letter she just received from the Ohio State Department of Health which was identical to several non-responses Keith has received from various “constituent services” (all unsigned) essentially claiming we have no standing/they have no idea what we are talking about, and it’s not their job to know. These letters of response invariably include the original Notice correspondence and make clear that their position is our claim has no standing in their codes/statutes.
- II. Federal District Court and Fairfield County Court statements by jurists clarifying our position in support and affirmation of Keith’s claim are discussed at length.
 - a. Beverly reads her written verification of Keith’s claim.
- III. A public letter written by Joe Ebel, Fairfield County Health Commissioner from 2021 where he was vehemently supportive of forced vaccinations is discussed. The consensus is that we ought to inquire whether, in the face of all current evidence, has his position changed? This topic is explored extensively with the ultimate goal of presenting ways Mr. Ebel and others like him have ways to restore themselves to honor, at least in some part.
- IV. Detoxing and shedding are discussed at length.

Conclusion: Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day comprehensible to the general population. As a local health commissioner, with over 30 years of public health experience, including managing both the current COVID-19 pandemic and the H1N1 pandemic, I have concerns with both the content and the timing of this bill. We are at a tipping point of the current pandemic. With the current surge of cases due to the Delta variant and Ohio’s low vaccination rate, the recent formal FDA approval of the Pfizer vaccine, including booster doses, and the pending approval of the vaccine for lower age groups, we are at a point where we can finally move Ohio past the pandemic for good. During this critical time where hospitals are overflowing with COVID patients, the General Assembly should be working with employers, educators, health care providers, and the general public to find ways to encourage vaccination rather than facilitating further delays in reaching herd immunity. By legislating restrictions on vaccine mandates and codifying an opt-out by simply stating a reason of conscience, with no justification required, this bill would gut any vaccine mandate by employers. Employers should be able to do what is best for the health and safety their employees and customers, including requiring vaccinations to protect their workforce, reduce the impact of disease on their ability to provide goods and services, and to protect vulnerable customers and clients.
