# Ohio State Jural Assembly Grand Jury Commission Saturday, September 6, 2025

GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these 'minutes' act as the active component of the Ohio State Jural Assembly jurist training 'handbook' by application(s).

**Common Law:** The historically known system of God's law all the way back to and including the Magna Carta and it's associated like-minded documents expressing the will and intent toward the greater good of mankind, NOT CODES AND STATUTES.

**Peer:** one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

## Athena - Cuyahoga

**Today's discussion** begins with the group deciding that elections will be held via Zoom with each papered member holding up their paper ballot with autograph for all positions being voted upon. The ballot will be mailed to the main OSJA post office box as soon as possible after the election by each member and will be collectively verified in the next soonest Zoom call after the election, as ballots come in. (Same as the most recent election).

NOTE this protocol was voted on collectively, unanimously, by the general assembly in October 2024 in an AFR mediated phone conference.

A separate, face-to-face meeting at the healing frequency center in Southeast Ohio is also discussed; the date of October 4<sup>th</sup> is agreed upon by all participants. Beverly is going to contact the healing center to schedule; she will advise the outcome.

# **Other topics:**

A new matter is inquired about regarding an elderly Russian woman in Cuyahoga County. **See recording for details.** 

Beverly discusses several documents to be sent to Fairfield County officials who did openly admit there is no lawful court in their county. **See recording for details**.

Lengthy conversation is had about other counties and the claims in process in each county. Commonalities between claims become apparent and the road forward is discussed. Various applicable code/statutes are sorted through as is the way to bring these to the attention of the man/woman who sometimes act as agent of the maritime corporation. Spiritual and karmic consequences and remedies are poured over.
