In Re: Account 31184

To whom it may concern:

It is my continued sincere desire to eliminate this controversy and peacefully return all men and women involved in this situation to honor. In lawful response to your renewed threats and allegations (see attached correspondence received October 17, 2025), I hereby (re)state and affirm the following:

The Ohio Revised Code §4123.01 sections (A)(1)(a) inclusive, (A)(1)(b), (c) inclusive does not apply to The Norton Deli, LLC dba JJ's Norton Café; further

Thank you for your written admission to the following two critical facts:

- 1) That you are, on behalf of the State of Ohio Office of the Attorney General, in collusion with the Ohio Bureau of Workers' Compensation in the perpetuation of conflict against the Norton Deli LLC dba JJ's Norton Café; and
- 2) That the original debt between the Norton Deli LLC and The Ohio Bureau of Worker's Compensation (their account 01733387) was reconciled by sending it 'to collections', now listed as account #311484.

Any exchange between myself, Jennifer Jackson acting as authorized agent of The Norton Deli, LLC, and any agent of the Workers' Compensation Bureau prior to October 7, 2025, was under duress. Previous temporary outcomes were due to lack of full disclosure on the part of the BWC, which, in itself constitutes fraud on the part of said agency. That the BWC incorporated in the attached letter of 09/23/2025, Dave Yost's Attorney General's Office (a State Agency) and 'local prosecutor' (presumably Summit County Prosecutor, Elliot Kolkovich), in this fraud, and the attempted extortion by you, Mr. Boich (see your correspondence dated October 1, 2025, attached), does seat both Ms. Patsolic and her agency as well as you and your agencies firmly in a clear act violating USC 18, Ch. 96, Part I, §1961 (e.g., acts falling under federal RICO statutes).

Your continued threats of *legal action, audits, 'and or penalties' including but not limited to injunctions and jail time* dated 09/23/25 and reinforced by correspondence received October 17, 2025 from the man, Mr. Robert Boich (see attached) are, on their face, fraudulent attempts to extort i, the woman. Based on the Internal Revenue Service Tax Code Regulations, specifically 26 CFR § 1.166-2, **the debt referenced has been reconciled**. The second correspondence from Boich proves this in showing the original account was successfully written off as this matter now has a new creditor (State of Ohio) versus the original creditor (Ohio Bureau of Workers' Compensation) and the new account number is listed as 31184. Unless it is your intent, Mr. Boich, to negotiate under UCC 9-608 regarding the overage, all communications on this matter are either harassment and attempted extortion or your attempt to practice law without a license.

Fraudulent extortion, premediated purposeful harassment of i, the woman intended to harm and trespass upon i. violates constitutionally protected rights of i to pursue happiness, and to be secure in my person, my property, and my papers. These violations are equally shared by the woman, Kathy Patsolic, Ohio BWC Special Investigations, John Logue, Ohio BWC Administrator, yourself, Robert Boich on behalf of the office of the Attorney General for the State of Ohio, David Yost, Governor Mike DeWine, with purposeful inclusion of the Summit County Prosecutor's office in the man of Elliot Kolkovich.

As my prior communication either fell on deaf ears or was unclear with regard to the Racketeer Influenced and Corrupt Organizations reference. As an edification, USC 18, Ch. 96, Part I, §1961, (1) through (5) inclusive and (7) through (10) inclusive. For easy reference, <https://www.law.cornell.edu/uscode/text/18/1961>.

Threats of extortion, malicious harassment, attempted robbery, threat to kidnap me, are all subject to previously defined lawful remedy (see my correspondence dated October 7, 2025, attached) in the amount of \$50,000 per man or woman noted by your own correspondence(s) as knowingly being involved:

Dave Yost	Mike DeWine	Elliot Kolkovich

Remedy per incident (each trespass is an incident) and \$1 per each minute I am forced to continue to educate anyone involved in these crimes of trespass on YOUR lawful obligations,

such date and time being October 17, 2025 at 12:00 Noon, four days and two hours ago (\$50,000 plus 5,880 minutes x four trespass' = \$23,520 and counting at 2pm October 21, 2025). Compensation to i for these debts incurred by the purposeful trespass harms by each man/woman named above are due immediately in troy ounces silver.

Written acknowledgement of the termination of this and all future fabricated pursuits against The Café or myself is anticipated within the next ten business days (October 31, 2025); should remedy be proposed in that same time period, amounts may be negotiated.
