Today's discussion

I. Composing a response to local municipality regarding the issuance, to the strawman listed on the registration of a traveling machine, of a demand for monetary compensation based on the use of an unmanned traffic camera.

This is a violation of ORC as modified by the Ohio 2025 Transportation Budget provision, enacted by the State House and Senate on July 1, 2025.

"The prohibition on unmanned traffic cameras in Ohio is primarily governed by Ohio Revised Code (ORC) Section 4511.093, as amended by House Bill 54 of the 2025 transportation budget. This law, effective July 1, 2025, bans counties and townships from using automated speed enforcement devices. Key statutes involved include:

- ORC 4511.093: Prohibits counties, townships, and their representatives from using traffic law photo-monitoring devices (e.g., automated speed cameras).
- ORC 4511.096 to 4511.0912: Outline strict conditions under which cities and villages may still operate cameras, including the requirement for a law enforcement officer to be physically present during operation.
- ORC 2935.26: Governs procedures for issuing traffic citations when a violation is directly witnessed by an officer.

 The ban was implemented to prevent revenue-driven enforcement and ensure accountability in traffic monitoring."

LENGTHY discussion illuminates MANY important points of Constitutionally protected rights, common law and maxims of law to include in the reply from a man to the man who do sometimes act as policy enforcement officer, which each living (wo)man must embrace to stand on and refuse to yield jurisdiction to A MACHINE.

11:05:11 From Ross Marley: ",,,,Walton Hills, Ohio, previously operated an automated speed enforcement program with cameras at locations like Alexander and Noddington, and Alexander and Independence. However, Ohio law now bans automated speed cameras in counties and townships, but villages and cities can still operate them under strict conditions. Recent state records show Walton Hills generated significant revenue from fines but was due a small amount from the state.

Past Program: Walton Hills previously had an automated speed enforcement program that used cameras to issue citations by mail for speeding violations.

Current Ohio Law: As of June 2025, Ohio law bans counties and townships from using automated speed cameras. However, cities and villages can still use them, provided a law enforcement officer is physically present when the camera is in operation.

Previous Fine Revenue: The village previously reported high revenue from automated speed camera fines, though much of that was not paid to the village itself due to agreements with the..."
