GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

Important details not written herein are to be gleaned from viewing the recording of this discussion.

THESE MEETINGS ARE NON-POLITICAL, NOT RESTRICTED TO MEMBERS OF ANY SPECIFIC ORGANIZATION OR RELIGION; CONTINUITY OF EXISTENCE FOR THE LAWFULLY DE JURED OHIO STATE JURAL ASSEMBLY IS A SECONDARY FOCUS.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law (‘Law of Mankind’): The historically known system of God’s law all the way back to including, and preceding the Magna Carta and it’s associated like-minded documents. All express the will and intent of the living man/woman toward the greater good of mankind. NOT CODES AND STATUTES OF DEAD CORPORATE ENTITIES (“citizen”, “person” etc.).

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

Today's discussion

- I. Continued discussion of Keith's efforts to communicate in a clear and peaceful way his determination that his prior consent to contract and allow foreign interlopers (in the form of umbrella corporation, its attorney and human resources representative, as well as the government and the internal revenue service) are no longer acceptable. The focus was to determine polite and concise language between the man acting as president of the company and Keith, as private consultant providing valuable services. Keith to meet via Zoom tomorrow to compose a delicately worded draft communication.
- II. Follow up conversation to update on current status of Ross' matter from last week regarding a "notice of liability" received by The US Postal Service issued by the Garfield Municipal Court on behalf of the Walton Hills Police Department where officer Michael Gervase did admit he was not present at the time an unmanned traffic camera allegedly accused the owner of a motorized conveyance of violating commercial codes and statutes in its operation. Cristina shared what she knows because Ross is not available this week due to his international family vacation.
- III. Initial discussion of the claim for harm by way of trespass against those man and woman who recently attempted to further diminish the God-given rights of The People of Ohio through the vote on amendment to the Ohio Constitution which would back-door ratification of the entire constitution. Lengthy feedback from all participants regarding the need to cease silently consenting to the limiting nature of constitution versus God's law. Notices expected to be forthcoming.
- IV. Continuation of discussion on VIN #s, titles and registration of motorized conveyances.
- V. Cristina clarifies that any Notice autographed by man or woman can be forwarded to her (original wet-ink and one color copy) and she will docket those items on the existing Summit County court case. Please do not hesitate to take advantage of this opportunity to publicly post your notices, whether they have become claims yet or not.
- VI. Notices to operators and owners of 5G towers and terminating/dismantling/removing them is discussed. Beverly, Kat and Cristina all intend to participate in this Notice process and thank everyone for aiding in the research and composing of these communications.

Reminder that each man/woman who presents evidence in any claim should kindly complete their own (3 sentence maximum) summary for inclusion in the final presentment; assignments on the remainder will be forthcoming via email from Beverly.

Conclusion: Each participant and those reviewing these meetings after the fact are asked to extract information from the study materials, along with each aspect we have discussed, with an eye to making the language of the texts we are reviewing more generally understandable, the idea of jural participation less complicated/more modern-day understandable to the general population.
