GOAL: exist in peace, eliminate controversy, restore honor, operate wholly in the private.

This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law (‘Law of Mankind’): The historically known system of God’s law all the way back to including, and preceding the Magna Carta and it’s associated like-minded documents. All express the will and intent of the living man/woman toward the greater good of mankind. NOT CODES AND STATUTES OF DEAD CORPORATE ENTITIES (“citizen”, “person” etc.).

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

- I. **Clark County / Champaign County Claims.** Our guest today has two different claims.
 - a. First, against local sheriffs for their robbery of her group of personal protective devices which she had stored off-property locally.
 - b. Second, her claim against a fraudulent mortgage which has been reassigned multiple times and the current banking organization is proceeding against her in foreclosure.
- II. **Passport.** Lengthy discussion revolving around the procedures suggested by both Badwolf Unincorporated and Copper Moonshine Stills. Many various endorsements and pieces of documentation are involved. Retaining living (wo)man status, native, and other clarifications are discussed.
- III. **Walton Hills / Garfield Heights Traffic Cam Scam.** Ross updates on his claim. *Extensive* discussion is had on the many options Ross has moving forward.
