This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law (‘Law of Mankind’): The historically known system of God’s law all the way back to including, and preceding the Magna Carta and it’s associated like-minded documents. All express the will and intent of the living man/woman toward the greater good of mankind. NOT CODES AND STATUTES OF DEAD CORPORATE ENTITIES (“citizen”, “person” etc.).

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

Today's discussion

- I. **Walton Hills / Garfield Heights Traffic Cam Scam.** Ross updates on his research into further pre-hearing correspondence to the court. Brief discussion is had on the options Ross has moving forward.
- II. **Passport. *Lengthy*** discussion revolving around the procedures suggested by both Badwolf Unincorporated and Copper Moonshine Stills. Retaining living (wo)man status, native, and other clarifications are discussed. Endorsements listed in several manuals are illuminated. How the passport / driver license / social security number details relate to banking, ownership of property and unlawful power of attorney over the living man is investigated.
 - a. The point is made about man/woman born on the land of countries *outside America* and it's firm league of friendship amongst the several nation-states hereon. Discussion culminates in recommending that those man/woman research their own nation's governance structure to determine precise etymology of geographic boundary designations; e.g., America has villages, townships, cities, counties, state as the language describing land rules; Canada has territories, provinces, cantons, and multiple other municipality designations, all of which carry meanings, restrictions and rules far different from those on America. In cases of other countries such as Pakistan, native born man/woman intimately fluent in their language ought to do similar research to gain deep understanding of what would equate to American "codes and statutes" versus common law language. This understanding must be sought before they should consider whether they desire or should choose to remain "a citizen" and what the ramifications might be either way.
- III. Brief discussion of new Clermont County CoS, new member(s) and how we have shifted our public image to attract the type of man/woman who is prepared to act according to the principles required.
 - a. Intent, purpose and direction of the Assembly, the grand jury and each man and woman participating is discussed.
 - b. Typical recruiting techniques will result in dismal failure as not everyone is built for the level of personal responsibility and action required to carry out our Jural Covenant Oath.
- IV. Beverly updates on her local Trustee's meeting and the outcome for her neighbor who wants to build an airplane hanger on his property. She stated on the recording to the Goshen Township Trustees that harm is being done to mankind due to their forcing exposure to EMF/Xrays (etc.) in order for man and woman to attend these public hearings.

- a. That these frequencies are being broadcast over the 5G tower/fiber optic network is discussed. Query is made regarding who is choosing the damaging/controlling frequencies when healing frequencies could just as easily be used.
