

ORDINANCE NO. 2024-18

Pursuant to the Village of Walton Hills Ordinance No. 2024-18 as amended, this program imposes monetary liability on the registered owner of a vehicle for failure of an operator thereof to strictly comply with the posted speed limit in school zones or streets or highways within the Village of Walton Hills.

On the back of this notice you will find detailed information regarding payment, adjudication / hearing rights and assignment of responsibility.

Failure to pay the civil fine or to contest liability within (30) calendar days is an admission of liability in the full amount of the civil fine assessed and will result in the loss of your right to a hearing. Late fees will accrue for failure to pay. In addition, you may be subject to formal collection procedures including, but not limited to a civil lawsuit in pursuit of judgment against you in a municipal court of competent jurisdiction.
