The Jurors of the Grand Jury of the State of Ohio, within and for the body of the County aforesaid, being duly impaneled and sworn and charged to inquire of and present all offenses whatever committed within the limits of said County, on their oaths, IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OHIO,

COUNT ONE

DO FIND AND PRESENT, that **JOSEPH SENK** on or about the 20th day of March, 2019, in the County of Summit and State of Ohio aforesaid, did commit the crime of **ILLEGAL TRANSPORTATION OF SCRAP TIRES** in that he did knowingly transport scrap tires anywhere in this state without first registering with and obtaining a registration certificate from the director of environmental protection, in violation of Section 3734.83(A), 3734.99(F) of the Ohio Revised Code, an UNCLASSIFIED FELONY, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT TWO

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **JOSEPH SENK** on or about the beginning in the summer of 2018 and continuing thereafter, in the County of Summit and State of Ohio aforesaid, did commit the crime of **OPEN DUMPING** in that he did recklessly dispose of solid waste by open dumping and the offense involved scrap tires, in violation of Section 3734.03, 3734.99(A) of the Ohio Revised Code, an UNCLASSIFIED FELONY, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.
