if you would like to assemble a second board of review or petit common law jury within fairfield county under sheriff alex lape for the purpose of resolving controversy, i, shall be most keen to present the claim there, provided that:

to best protect myself and those of man and woman who will serve to witness and/or present evidence:

no man or woman who serves as jurist, court officer, or attendant, shall have been injected with a "vaccine," since the

october 1, 2019;

similarly, no one who has been nasal swab tested, during the same timeframe, allowed in court;

no british accredited registry members, except he or she be there in the capacity of a man or woman;

no wireless or bluetooth communication devices of any kind shall be permitted in court, whether powered on or not;

if the man, r joseph ebel, do permanently vacate public office within seven days of this notice, march 6, 2025, this shall be accepted as remedy, and debt forgiven;


repeated failure to respond appropriately, i, shall continue to seek both earthly means of collection, and divine intervention;
