i: keith alan mauger: a man; do state:

i, have no claim against the CITY OF LANCASTER, LANCASTER BOARD OF HEALTH, FAIRFIELD COUNTY BOARD OF HEALTH or DISTRICT ADVISORY COMMITTEE; efforts by the man, don mcdaniel, by and through the british accredited registry agent the woman, stephanie hall, do not alleviate, alter or convert the responsibility of the man, don mcdaniel from his obligation under the Ohio Revised Code Sections, 3709.03 in his voluntary position representing mankind on lancaster;

i, do claim trespass by way of harm and trespass by way of debt against the man or transhuman, don mcdaniel; acting as lancaster mayor;

the title, mayor, do hold responsibility to protect those on lancaster and this claim does stand under law, unanswered;

no communications from a third party can absolve your lawful obligation to cease the trespass and resolve this harm; intercessions by third parties on behalf of the man, don mcdaniel, are added controversy, dishonorable and do trespass onto the claim of i;

as fairfield county does sorely lack a court record to hear

claim under common law, where a jury of man and woman who qualify as peers do verify this claim, thereby equitably ending any controversy and restoring honor to all;

i, did seek the assistance of verification from a review board composed of twelve of man and woman of the lawful de jured government, ohio state jural assembly; said group is not associated with any political party or the entity known as ohio state government;

if you would like to assemble a second board of review or petit common law jury within fairfield county under sheriff alex lape for the purpose of eliminating controversy, i, shall be most keen to present the claim there, provided that;

to protect myself and those of man and woman who will serve to witness and/or present evidence:

no man or woman who serves as jurist, court officer, or attendant, shall have been injected with a "vaccine," at least since october 1, 2019;

similarly, no one who has been nasal swab tested, during the same timeframe, allowed in court;

no british accredited registry members, except he or she be there solely in the capacity of a man or woman;

no wireless or bluetooth communication devices of any kind shall be permitted in court, whether powered on or not;

persons who have been vaccinated may attend via zoom, skype, or the like, signal to leave the court by ethernet cable;
