greetings to the man: branden c meyer; who at times acts as
fairfield county clerk of court:

i: a man: keith alan mauger; say: when those of
mankind do trespass on the rights of i; comes time to come
forward as a man, present in honor, to seek remedy of
trespass between mankind and i, the man, in this instance:

r joseph ebel: a man or a homoborg genesis, who
sometimes acts as fairfield county health commissioner; don
mcdaniel: a man or a homoborg genesis, who sometimes acts
as mayor of lancaster; steve davis: a man or a homoborg
genesis, who sometimes acts as commissioner of fairfield
county;

i, say: after many attempts to resolve this matter in

private and to operate as a man with rights, no remedy has been offered from any of the above listed man and woman; instead, only more trespasses; this has led to the demand for a room to hold a court of record, to press claims of trespass; to present i, before a magistrate compitant at trespass law; there to keep the peace and put forth the orders of restoration of honor; i wish to press these claims on those whom i, believe have done trespass on the rights of i, and whom have been noticed of these trespass;

i, do require a magistrate to affirm the verdict of the jury

as i, do require a court which harms neither i, nor those who witness on behalf of i, all must meet the following criteria:

- no man or woman who serves as jurist, court officer, or attendant, shall have been injected with a “vaccine,” since october 1, 2019;
- similarly, no one who has been nasal swab tested, during the same timeframe, allowed at court;
- no bar associates, except he or she be there in the capacity of a man or woman;
- no wi-fi or bluetooth device either powered on or not;
- no mobile phones;
- persons who are vaccinated may attend via zoom, skype, or the like, signal to leave the court by ethernet cable;

all evidence offered shall be available to the jury; that is, no third party may screen the evidence; this evidence to include oral and written statements from man and woman of the ohio state jural assembly review board, which has extensively examined and continues to investigate evidence supporting this claim;

shall not diminish the status of i: that of a man who presses a claim, and retains all rights;

i, have chosen to be present before a court of record under oath, there to testify with facts to support claims of trespass by way of harm and trespass by way of debt; i, require no legal advice, no legal forms, as i, am not part of the bar association and these are claims; i, submit no complaint, tort, nor suit;
