Over the past four years, I have become acutely and painfully aware of the effects of vaccine shedding; here I describe some of my experiences with it.

I attended a family reunion on 21-24 June 2021; I returned to discover, over the next week or so, that I had developed a rather severe case of peripheral neuropathy in my legs. I assume that the shedding adversely affected my circulation and peripheral nerves.

I have since turned down invitations to further family events, much to the disappointment of both myself and my daughter.

To date, I have not recovered from the neuropathy.

I have reacted to vaccinated persons while at my church over the last six months or more. I don't know why this has just started relatively recently; perhaps the shedding is worse, or the toxins have built up over time. My symptoms include: neuropathy in lower limbs, head pressure, upper back pain, stinging and burning eyes.

I value the teachings that I receive while attending church; and so I have taken to sitting in a small private room at the back of my church, so as to decrease social contact with the many vaccinated people who are my fellow church-goers. I simply can no longer allow them to make me sick.

I have a friend in North Carolina with whom I talked by phone for three hours, several months ago; and when I got off the phone, I had the same symptoms that I have gotten from contact with fellow church members: head pressure, worsening of neuropathy,

upper back pain. This experience shows me that I can react to shedding even over the phone.


A woman at my daughter's school was told by her doctor that her heart problems are probably due to the covid vaccines. I was amazed to hear that a medical doctor admitted this; and I feel certain that he is right.

Through many awkward social interactions, I have found that covid injected people, for the most part, are not experiencing shedding; they do not seem to readily understand what it is; and they try repeatedly to find some other explanation for my symptoms; they wish so strongly to avoid implication in harming me that they tend to remain in denial, reluctant to admit that they are shedding.

Over the past few years, I have become progressively more able to identify symptoms that result from shedding; that is, I have learned to feel it while it is happening. This allows me to exit certain social scenes before my symptoms become severe.

i: beverly jean welbourne: a woman; do state: i, have been harmed by horizontal so-called "mRNA vaccine" transmission very many times, over the past five years;

i, estimate the number of such incidents at more than three-hundred;

extensively have i, researched the causes and effects of shedding; they are massive, severe, and global;

i, do attest and understand that keith alan mauger: a man; has been and is harmed by horizontal transmission;

i, do not accept misunderstanding as an excuse, since keith and friends have been informing man and woman who sometimes act as public servant of the severe risk of continuing down this path, for many moons; more than five years ago, i, became aware that these injections were and are harmful to all biological life; so i, have both witnessed and experienced repeated and profound harm through this horizontal transmission; i, do declare an end to any game in which there is implication that someone who lacks awareness that these injections constitute a lethal, multidimensional bioweapon may have any authority whatsoever over the life, liberty, or security and safety of body and soul, of a woman or a man;

over the past three years, i, have experienced the following symptoms and signs, during or shortly after exposure to injected persons, and which i, do attribute to such exposure:

hemorrhage from ears, nose, rectum, vagina, bladder, throat, lung

ocular hemorrhage, a very painful condition which has affected my vision, and which has become chronic

throat swelling or irritation, sore throat

headaches, commonly occipital, parietal, and frontal

brain fog, confusion, slow thinking

transient aphasia

disorientation in space or time, sometimes leading to falls or minor injury; uncoordination of left and right or arms and legs

sinus irritation, pain, or pressure as though a cold is coming on, with sneezing, cough, and runny nose

bruising on hands or arms, usually from directly touching the skin of an injected person, occasionally from proximity alone

pressure or pain in ears, temporary dulling of hearing

tinnitus, frequently sudden-onset upon exposure

pain in appendix

muscular cramps in legs or feet

chest tightness, spasm, pain; difficult to inhale; poor perfusion while breathing hard

nausea

heart spasm and pain; sometimes feels as though my heart is struggling to beat, or jumping out of my chest

tachycardia, usually briefly, upon initial contact

extended periods of elevated heart rate, even while lying down

vertigo

abdominal spasm or pain

spasm or aching in spleen

diarrhea

lienteric stool

ovaritis, sudden sharp pain or aching of ovaries, or generalized pelvic pain, pelvic inflammation

bladder spasm, urgency to urinate, similar to UTI symptoms

anxiety

insomnia

unexplained mood swings

shortness of breath

sudden-onset weakness

fatigue, frequently sudden-onset

visual blurring or distortion

conjunctivitis

rashes, often continuing for several days after exposure

cysts, developing the following day at a site of skin contact with a vaccinated person, slow to resolve

feeling of dread: oh, no, i feel those toxins again!

feeling of panic or fear at the strong possibility that i, am getting yet another headache, and my breathing is being inhibited—again—by these same, now-familiar toxins

kidney pain

body aches

fever

plantar fasciitis

cough, excessive phlegm

lymphatic congestion, especially inguinal, axillary, submandibular

asthmatic wheezing

coccygeal nerve pain

neuralgia in hands, legs, feet, neck, head

high white blood cell count, observed under microscope through live blood analysis in october 2023, accompanied by fatigue and mild fever;

i, have witnessed harm and even death as sequelae of the injections; i, have observed deaths of several animals after a

suspiciously short interval since the owner's "vaccination"; as described above, i, have experienced repeated harms through vaccine transmission; i, have subsequently missed several weeks of my usual engagements, thus interrupting pursuit of happiness; because of the toxicity involved, i, ceased helping those of mankind who have been injected with nanotechnology "vaccines," which has quite negatively impacted the livelihood of i, and functioning with regard to my previous offerings of skin-contact-related assistance; these injections have transformed a man or woman who formerly paid me to facilitate movement of qi for him or her into a carrier of toxic chemicals and relayer of noxious radiation; since proximity to an injected individual disrupts the electrochemical functioning of my heart and blood, my life is currently at risk in any public area on the state; and i, have not consented and do not consent to the substantial and continuing health risks, including the risk of genetic alteration, of increasing social and environmental exposure, to both disclosed and undisclosed toxins contained therein or to which these injections give rise; the covid 19 nanotechnology injections and other "mrna vaccines" containing advanced biotechnologies, actually bioweapons, were administered, undisclosed, to gullible carriers-to-be on fairfield county, with the cooperation, engagement, facilitation, and, indeed, promotion of R Joseph Ebel and others for whom he is responsible; his activity and that of others with whom he is associated has continued long after having been informed that much harm has been caused; such biotechnologies have been unwittingly transmitted to the unvaccinated, such as i, and such as keith, through proximity and normal social contact, without consent; there is no statute, no rule, no mandate, no duty, no contract, no grant, no emergency, which may supersede law to allow a man to cause harm to a man;

Claim verification #3

There's my friend Daniel Michael Eggers who died suddenly on March 7th, 2022 after having been double vaccinated with what I believe was the Moderna version of the Covid-19 vaccine. He was double vaccinated sometime between February 5th of 2021 and the time of his death. The coroner tried to claim that he died of congestive heart failure. That cause of death was arrived at no less than three months after his death. If he was actually suffering from congestive heart failure, then I didn't know Dan very well (I had known him and his family for over 30 years.). When we parted company at approximately 6:00 p.m. on Saturday, March 5th, he exhibited absolutely no signs of being ill in any way. He was the same old Dan that I had known these many years.

I followed up with the Clermont County Coroner in late October, 2022 to ask them about any heart medications that Dan may have been taking prior to his death. The closest thing that the coroner's office could get to heart medications were high blood pressure medications. As you may recall, the coroner said he had died from congestive heart failure. It seems to me that the cause of death was sudden and unexpected to coincide with what Dr. Peter McCullough professed as part of Steve Kirsch's Vaccine Safety Research Foundation Weekly Webinar. His statement ran that if an individual has been Covid-19 vaccinated and dies suddenly, it is to be assumed that he or she died as a result of the Covid-19 biologic unless proven otherwise.

Regarding Dan's death, I concur with Dr McCullough.

In addition to grief around the senseless loss of my good friend, I've had more recent concerns for my own health. At church last week, I experienced chest pain while in physical proximity to a

certain church member. I am certain that she is vaccinated, probably double-boosted.

When I got back home, the pain was gone, and I was fine.

I am considering this an incident of shedding, or transmission.

The presence of Covid-vaccinated (weaponized) people in the populace poses a direct threat to my health, for which I am holding the Clermont County, Ohio officials and their compatriots responsible.

So many of these pandemic exercises have been conducted by the Johns Hopkins Center for Health Security and the Bill and Melinda Gates Foundation. There was Clade X on May 15, 2018 that occurred in Washington, D. C. followed by Event 201 on October 18, 2019 that occurred in New York, New York and that was followed by Catastrophic Contagion that occurred on October 23, 2022 in Brussels, Belgium. The intended goal of each of these forums was to war game how to deal with future pandemics. Along the way, it was determined that if you could succeed in frightening enough individuals that their very life was in danger, then the powers that be could succeed in getting those same individuals to do almost anything to save it. This is not to minimize the impact that the World Health Organization has tried to have on past, present and future events.

Please don't doubt the fact that these same organizations plus our own FDA and CDC will try to use these same scare tactics regarding the H5N1 Bird Flu if we let them. Give them a finger and they'll take the whole hand.

I have experienced muscular and nerve pain after substantial and repeated exposure to horizontal "vaccine" transmission; I do believe that I am experiencing harm from shedding.

I am a registered nurse with over forty years of nursing experience. I was vaccinated with Moderna:

March 18, 2021: 048A21A

April 15, 2021: 037B21A.

I believed it was "safe and effective" and wanted to do my part to "slow the spread." Three weeks after the second shot, I experienced chest pain. I was within minutes of an emergency room and checked myself in. When the triage nurse was getting my vital signs, her first question was, "Are you vaccinated?" At the time I thought it was in relation to the possibility that I had covid, but now I no longer believe that to be the case; I believe that she already knew that the covid vaccines could cause cardiac problems. I was transferred to Clifton Christ Hospital to the cardiac care unit for further testing and overnight observation. My enzymes tested normal, and I was discharged; but it was a very painful, frightening and expensive experience.

My husband was admitted for open heart surgery at the end of March 2020, and I was not allowed to see him post operative. My sister was in a nursing home, and I had to visit outside, standing in a rose bush with the window closed. She was diagnosed with covid at one point, and I was unable to visit her. Why? She supposedly had covid, so what was I going to do to her? If masks worked, and the vaccines were effective, why weren't loved ones allowed to visit their vulnerable loved ones?

To this day, I find these sorts of policies confusing and emotionally damaging.

Could it be that a vaccinated person was considered dangerous because of the findings in the vaccine serum, of DNA with the mRNA, and the finding of Simian Virus 40, a known retrovirus which prompted the Florida attorney general to call for a ban on the covid vaccine in Florida?

Why hasn't the cancer incidence data been updated on the Ohio public information data since 2020? Rather odd, isn't it?

If a retired nurse such as myself became alarmed at the above, where are the paid medical gatekeepers for Clermont County? Who was tracking the signals that are to be monitored by the physicians appointed to the health board? Is all this harm intentional?

I testified on Ohio HB 73 intending that no one must die alone. I listened to others testify on how people were isolated and treated with questionable medications at \$6,000 dollars a dose, but Ivermectin, a safe effective drug which was awarded the Noble prize in 2015, was banned by the pharmacy board in Ohio. This is a drug dispensed over the counter in Africa in millions of doses, so why was it banned? Where was our health department? It should have been doing its job to correct medical disinformation while a safe medicine was insulted and forbidden, called a horse dewormer.

In the fall, I met a chemist who offered to perform a dark screen microscopy test on my blood. It was performed on 12/26/23. He

has performed thousands of these tests since the 1990's. Also present was a practitioner who has been astutely following international vaccine study groups for the past three years.

The first thing noted was my blood clotted quite quickly. There was also noted a blob of something described as a hydrogel-type substance. Then, near the end of the session, there were two very small kinetic orbs much smaller than the clotted red blood cells. The chemist had never seen them before. They are in my body; what are they? They look just like the kinetic orbs or nanobots of several other microscope studies, shown to have been introduced through covid injection. If at least two were in a small drop of blood, how many of these are floating in my bloodstream? I do affirm: I did not and do not consent to having these put into my body.

I see a cardiologist once every two years. Before the shots, I had stable mild tricuspid valve regurgitation. Last year I had three leaky valves, my tricuspid jumped to moderate and two other valves to mild regurg. So if my blood is getting thicker, more likely to clot, it makes sense that my heart is working much harder to pump more viscous fluid. Yet this had been stable since 2007—until after the covid injections. Odd coincidence? I do not think so.

These are questions for everyone: Are you vaccinated? Is your spouse, your parents or even your children? The covid vax is still recommended on the Clermont County website at 6 MONTHS and older. The vaccine is still being promoted, despite multiple indications that it is causing harm.

There was an incident with my friend, who told me only after we had been in a closed car for two hours, that she had just been boosted, with covid and flu on the same day; I was very angry and rolled down the windows; I asked: Why was I not informed ahead of time, and how could she do this at all when I had told everyone I knew not to get them?

At the gym, I sat between two gentlemen who spoke about having recently received boosters, and I moved; one is a pharmacist and one an engineer, not uneducated people. I moved because I was afraid of their shedding.

I know that I am shedding. I am still in shock that our government did this to us. I have no words to describe how I feel; the combination of disbelief and horror is indescribable.

Without my consent, I have been made into a bioweapon, incapable of refraining from harming loved ones who are near to me. I do call upon those who promoted, distributed, or failed to stop these frankenshots, to accept responsibility for their actions; they are the primary ones who harm the uninjected through shedding.

With elected positions comes great responsibility. Elected officials appointed all of those who were and are in direct contact with distribution of the injections. Among these officials are those who are responsible for appointing members of the health board, which then appoint/hire the health commissioner. There is or should be a buffer of accountability between them and us. I write

now to place a face and a name for someone who has been directly harmed in this travesty. I do request that all departments, starting with the health department, be led by innovative questioning of the status quo; that is, by someone willing to engage in real, thorough inquiry; this would include hearing from voices such as mine.

I quote Norm Chomsky: "The general population doesn't know what's happening, and it doesn't even know that it doesn't know."
