affirmation of true fact told in story form

i kathryn ann oscker a woman do affirm the claim of keith alan mauger a man, who claims harm by horizontal transmission shedding of the various C.O.V.I.D.-19 vaccines; i affirm that i have experienced this type of harm myself first hand and do join the claimant in agreement of harm; my multiple symptoms and experiences outlined here are to be included as testimony affirming i also do claim harm;

2020 the C.O.V.I.D-19 planned pandemic was Announced 3 days after i started a non profit to be the overall structure for self sufficient, self sustaining, mostly off grid community (s) designed to to lift people out of poverty; providing solutions and food security; C.O.V.I.D.-19 curtailed my efforts to a stop; from the first whispers, i personally did not believe any of the narrative, i did not wear a mask; social distance or stay inside at home; i cut a piece of open weave lace cut into a gaiter scarf; or a carried a face splatter shield at medical appointments for my brother;

i have never received a C.O.V.I.D.-19 vaccine; my husband is also not COVID vaccinated; nor have i, taken a C.O.V.I.D.-19 test swab/stick which are infused with ethylene oxide and a nanochip; for the purpose of planting a nano chip, shoved up the nose while aimed at the pineal gland just below the surface of the blood brain barrier; historically a stick up the nose was a punishment for slaves during the era of egyptian pharaohs; the nano chip is magnetic and the pineal gland is also when calcified with fluoride;

april 2020, my husband was next of kin and medical power of attorney for his uncle who had a seizure while living with my husband's mother: uncle was coherent and hospitalized to determine brain tumor status; he received C.O.V.I.D.-19 vaccine and protocols; uncle spoke to us by phone; we were denied hospital visits with him; his doctors phoned my husband as he was uncle's medical power of attorney; while test results took a week; uncle suffered a massive stroke, incoherent and unable to speak or swallow; we were told to choose 3 nursing homes; we gave our home address 3 times;

uncle's emaciated body came by ambulance masked, twisted, soiled, dehydrated on hospice care to die with slow shallow labored respirations, and no gut sounds; uncle lasted 6 days, of which i was his only caregiver, a hospice nurse came 1 hour a day; when uncle arrived he stank i immediately removed the stiff foul diaper; feces stuck firmly back to front revealing bedsores; obviously no hygiene was given in hospital after the stroke; i changed diapers he was catheterized, his urine was brown; i turned bathed changed, linens, gave mouth swabs, and removed bloody scabby puss and scum from his his mouth he presented with strange random black bruising;

i immediately began experiencing the horizontal transmission reactions due to the C.O.V.I.D.-19 vaccine uncle was injected with upon his arrival. i felt unsteady, i noticed a ringing in my ears, stiff neck, fatigue, dry sore throat, the unsteadiness became dizziness; later on that day started the first pounding headache, followed by mild nausea, uncontrollable coughing, sore throat, disconnected thoughts, heart pains, tightness in my lungs; soon after began the unexplained bruises upon my body, skin rash, nose bleeds, and some breakthrough menstrual bleeding although i had a hysterectomy years earlier; i laid down once uncle was comfortable and my husband was home; i pressed on to take care of uncle; to care for my self, i sucked on pineapple, took colloidal silver water, teas and home remedies; i do affirm this was the first horizontal transmission shedding i had experienced from a COVID vaccine.

january/february of 2020, my mother & uncle in law got flu shots.

my mother in law visited us and her dying brother almost daily; i recall she was fatigued, tired, declined rapidly after her brother's death, she was haggard, disheveled with no appetite; her daughter would not visit her mom if we were visiting mom, because we were not vaccinated; uncles's ashes were returned with no fanfare; mom visited less and seemed disinterested in everything;

3 weeks later we visited mom on mothers day of 2020; i recall her re-heating rancid soup when we arrived in the microwave; the smell was disgusting, mom could not smell it; i threw it out and made a meal; mom was frail distant ate little, she complained of fatigue headache and diarrhea; yet seemed oddly content;

24 hrs later, mom had her second stroke, my husband sat with her in the emergency room no one was allowed to see her after; she was forced to wear a mask; test swabbed for C.O.V.I.D.-19 and given COVID protocols as she declined; she was put on oxygen; unable to speak or swallow; mom's emaciated body came masked on hospice care; she died 8 days later;

i was her only caregiver, a hospice nurse came one hour a day; i changed the diaper bathed changed the gown, linens, and turned her; i removed the scabby puss/crust forming in her mouth when giving mouth swabs; she had strange unexplained bruising; she rubbed at the bruised dark circles under her eyes;

i started searching online reading about causation(s) of her symptoms, it were as if she was dying from poison or venom; in the chaos & grief i thought i might be nuts; as all the previous symptoms i experienced 3 weeks earlier were coming on again; i know now these symptoms are the second time i had experienced horizontal transmission "shedding" from people who took COVID vaccines; and it was worse; when mom died i was loosing gobs of hair, my overall skin was dry and itchy; a rash became hives, then welts, then many painful itchy open sores, they first had the appearance of infected ingrown hair and seemed to be attached to nerves; although i had suffered with sensitive skin my whole life; having a few blemishes most of the time, this was blisters covering 1-2 per every 4 to 6 inches of my body;

the wounds were painful and looked infected; i repeatedly removed debris from the wounds to rid the source of infection, i repeatedly discovered multiple colors of hairlike tiny threads from within the scabs that would raise out of the skin as if volcanic, starting on my arms, shoulders, and face; often i experienced sore scratchy throat or tightness on both sides of my neck with deep pain in my upper spine; at times, i felt i was imbalanced and not in control of my muscles; i had random arthritic aches, sometimes to the point of keeping me in bed and making me cry in pain; all of these symptoms have continued in various severity according to my interactions C.O.V.I.D.-19 vaccinated people since that time;

in fall of 2020 we were invited to mom's cousin's home for dinner; i began feeling ill upon arrival; they made it known after dinner that they were vaccinated; and were horrified when we said we were not; the evening ended on a very strange sour note; the itching was so intense; once home i got in the shower and stayed in there as long as hot water lasted; the rash that came over me, was like having poison ivy and it wrapped around my body and face; i went to see a dermatologist about my skin; my eye was swelled shut; the young woman, a resident doctor in training looked at me like i was nuts; she said I was describing mortegellions; that i was hallucinating or delusional on her computer she read that it was a delusional mental condition where the patient believes there are fibers coming out of the skin; i left before they could attempt to throw me in a room with crayons for an extended stay;

since i dumped my health plan as it only offers crude oil creams pills and surgery, i see my chiropractor when i need to; i skip mentioning the blisters that become enflamed from being close to C.O.V.I.D.-19 vaccinated people; the fibers are visible with a 30x microscope in the skin, the rash is all over me; i wear long sleeves

i do affirm when i am exposed to C.O.V.I.D.-19 vaccinated people my symptoms worsen; with more skin eruptions and or intense itching; headache, cough, unsteadiness, i am embarrassed and tried to hide it, as if i have the plague; my husband has been wonderfully supportive, how am i so sensitive and he has not experience any of this while intimately living together? i took one flu shot in 1993 and almost died; my husband hasn't had a vaccine since childhood;

i visited Great Wolf Lodge, i was feeling uneasy fatigued and dizzy in the pool area with my grandchildren who swam all day; at dinner the backs of my thighs were already blistering into hives; we ate then drove an hour home; i was exhausted fatigued fell dizzy into bed; next morning i was covered in little itchy bumps that were growing larger; my head was pounding, when i tried to walk, i felt as if my feet were dragging upside down under me; as if my body was trying to walk on the tops of my feet rather than the bottom; the damage seemed neurological like i could not move my muscles as i wished; getting my granddaughter out of the pool i lost strength and twisted my back;

For 6 weeks afterwards i went to the chiropractor for treatments; for four weeks the fatigue and pain was awful; a spinal alignment was previously one or two visits, and i am fine; my recovery time has slowed tremendously overall each time i experience horizontal transmission shedding from COVID vaccines; these blisters were significantly larger and more painful similar to venomous spider bites; which i spider bites around 2016; these blisters extended to my ankles, they began in jagged lines, then broke out into large scabby horribly painful ugly blisters; i was embarrassed; i wore loose cotton pants or long skirts all summer into the winter even to bed;

my brother john's health went to hell after 2020; in 2017 john was diagnosed with basal cell skin cancer; throughout his life, he had experienced many horrific injuries, including a traumatic brain injury; as he aged, he was weaker and less stable; john had so many skin lesions on him; they were painful, and he wept in despair. 2022 a nodule on his temple opened into a hole in his face; the woman who worked on him in a clinic put aluminum oxide on it, which made it stink; it grew and mushroomed into double its size in less than 10 days; he suffered multiple strokes; the doctors decided to patch his face with a piece of skin muscle and blood supply from his leg; it crippled his leg; Upon arrival for his surgery the Dr. would not do the surgery unless they vaccinated him for COVID 19;

john left the hospital faced patched with leg hair on the patch going in the wrong direction; i don't know which was worse the patch or the hole in his face; most shocking was his green eyes where hazel after the surgery; leaving the hospital after visiting him all the horizontal transmission symptoms really hit me; this time it included heart pains; i huffed and puffed my way to my car took a baby aspirin, later i fell into bed sobbing in pains of muscle fatigue and female cramping my scalp hurt and the pillow was littered with hair in the morning;

john was jovial by nature, we were close; we'd laugh talking about anything; after he was vaccinated, he was different; he was distant, bitter and sullen, i never again heard him truly laugh, except a snicker or in disgust; physical manifestations of headache, fatigue, rash, breakthrough bleeding, blistered skin, swollen glands, charlie horse cramps, stiff neck, dizziness and nausea were common when he was present;

john had a series of strokes until he was unresponsive, and came to my home to die on hospice care; my brother had the same scabs in the mouth that was somewhere between puss, and a coating of scab; i saved a sample of this, a few days before he died; i used a mucus suction machine and a hemostat to remove it from the palate to avoid him choking; john was 6' 4" and a handsome man once upon a time; i said goodbye to him, holding his hand as he died; i miss him terribly; john looked 95 yrs old, he was 60 when he died; his green eyes only returned just hours before john died; i was a nonfunctional mess full of blisters nausea dizziness and clumsy injuries, for at least 2 months;

aj and my husband were friends 40+ years; aj was vaccinated for COVID in order to receive back surgery which after he got the Covid vaccine he was never healthy enough to receive the back surgery; aj was 57 years old when he died; the same as the others, he went into a coma after having a stroke, could not speak could not swallow died in the hospital five days later; i saw him the day before he died; leaving the hospital, i had a nosebleed in the elevator, stumbling in the parking lot i had extreme fatigue, soreness, and again the blisters worsened; my hair got thin over that summer; so much so that i started saving it and filled a shoebox;

bruce was 78; he had lived 8 years needing a liver liver transplant in order to receive the surgery the doctor required a Covid vaccine; after, bruce he had multiple falls and multiple strokes in and out of the hospital; he never was healthy enough to receive a liver; he had a final stroke, couldn't speak couldn't swallow bruises appeared he died after a few days; my husband visited him alone; as the dying causation of harm to i is too great;

my adopted sister, at 38 years old, received three COVID vaccines in one year, approx 30 days after receiving the third COVID vaccine; she had a stroke in the attic bedroom; no one checked on her for over two days; she laid in a puddle of waste with roommates in the house; she too had a stroke; unable to speak or swallow; i gave her marijuana oil in her belly button; on her behalf i refused all COVID protocols; i cut the strings off the mask and told the nurses she has asthma they protested; i firmly said i am her medical power of attorney for medical decisions; she is right side paralyzed yet alive; each time i visited her i was ill afterwards for about a month;

the boyfriend of a friend of mine announced she would get a COVID shot or move out; she, boyfriend and his son got a COVID shot; that week the son almost died; since her boyfriend has multiple times passed out fallen twice hitting his head on the driveway; recorded by doorbell video, it also recorded him falling off the lawn mower; desire has left him; christian tv has replaced previous beloved sports channels; she herself seems less stable on her feet and is sick with 'the flu' every few months; i see personality changes in most all the people that have told me they took COVID injections; the normal range of emotion isn't there, as if they take cognac & prozac; their passions became meaningless;

a 20 year friendship is finished with a now COVID vaxxed woman whom previously was a soft spoken devout and very kind; is irritated about everything, i attempted non-confrontational conversation; i asked about her church she loved; she emphatically stated that she no longer believes in God; i was shocked and puzzled; she got angry; i tried to change the subject; she got angry about that; the rest of the entire visit was her being angry; before 2020 i had a thriving business; now i do three clients average which buys me a tank of gas. now my COVID vaccinated friends, i rarely see; 2 have bell's palsy, 1 has parkinson's, and another, had open heart surgery to repair a hole through the heart; all were healthy prior to being vaccinated;

i notice people with ocular hemorrhage; the whites of the eyes are bruised; being near some vaccinated people, i have the sensation of being barbecued from the inside out; as if they are emitting microwaves; at times in public; i feel my heart just stop; i have to reset the rhythm by coughing; i go out mid day when restaurants and shops are not busy; i wear nicotine patches and carry a frequency device to stop the electromagnetic radiation, vaccinated people emit or transmit; see studies on 6 G to understand the phenomenon.

After visiting my sister during her 2 week hospital stay, i felt like i had lost badly in a prize fight; it isn't arthritis, my symptoms were that of radiation poisoning; hair loss rashes nausea headache dizziness, loss of taste and smell, i conclude no other logical explanation from any or all of these and other instances too numerous to list; than horizontal transmission shedding of the COVID Vaccines to i, one of the unvaccinated;

i have chronicled many aspects of the harms i have experienced here upon the public record; therefore with similar experience i find no other logical explanation other than horizontal transmission of the COVID vaccines has happened to me; therefore i do verify the claim of kieh alan mauger.

My name is anita foster and I have been harmed by exposure to "mRNA vaccinated" people via horizontal transmission, also termed shedding. Exposure has created numerous health issues in my body that I never experienced until the population started being injected with the Covid-19 vaccine four and a half years ago. Therefore, I do attest that keith alan mauger is being harmed by horizontal transmission from mRNA vaccinated people.

Some of the symptoms I have experienced from associating with mRNA injected people are:

Ocular hemorrhage

Painful lesions on both sides of the base of my tongue

Skin lesions

Unusual amount of sinus issues

Coccygeal nerve pain

Sciatica

Muscular spasms and cramps in my legs

Muscular wasting; weight loss

Thyroid and metabolic anomalies

Peripheral neuropathy bilaterally

In January of 2024, I had live blood analysis done. The samples showed my blood cells with a predominance of poor zeta potential, tendency to micro-clotting, diminished oxygen capacity, non-optimal shapes of erythrocytes and other unhealthy anomalies which are consistent with the findings of researchers who have been studying the blood of covid-injected people for the past few years. I have no prior blood disease and I did not receive any of the covid-19 vaccinations. However, my blood looked as though I have been vaccinated. It is my experience that shedding is a real and common phenomenon, especially in areas where there is a high concentration of vaccinated population. Virtually everyone I have worked with is vaccinated.

In June 2025, I had another live blood analysis. There is no improvement; in fact, there are even more unusual anomalies than 18 months ago. These anomalies are consistent with evidence of nanochips forming in my blood; I have seen such in other research. Appearance of these formations coincide with the worsening of my symptoms. I firmly attest that horizontal transmission, shedding, is real.

I have unvaccinated friends who are experiencing many of the same symptom as myself plus additional symptoms. It is my position that many other people are experiencing shedding and it is not just limited to my experience.

Greetings to branden c meyer: a man or a homoburg genesis; who sometimes acts as clerk of courts for fairfield county, ohio:

i, do offer evidence that both direct injection and horizontal transmission of modRNA nanotechnology "vaccines" are harmful as follows:

In my family circle, two of my cousins and their wives had the same experience after their third covid vax shot. On separate occasions, each couple had gone as husband and wife to receive their injections. And both couples became ill with covid three days after their shots. Because the same result occurred in four people 3 days after their shots, it is my firm position that these four illnesses were the direct result of the covid "vaccine."

A friend I've known for 19 years, still in his 40's and full of vibrant health and a Cub/Boy Scout leader for over 10 of those years and accustomed to "roughing it" outdoors, who had been partaking faithfully of the entire series of shots, all of a sudden in 2023 presented with atrial fib and rather severe blood clotting. Because he never before had any sign or symptom of any cardiovascular illness, it is my firm position that these two sudden illnesses were caused by covid vaccine injections.

In addition to the above, I have seen firsthand and witnessed the telling of many people's experiences with horizontal transmission symptoms. Because of what I have directly experienced, I do attest that shedding is very real. One unvaxed friend has had over 200 incidents, and I have personally witnessed her having many of these symptoms. She has had coughing, prostration, malaise, muscle weakness, dizziness, and more. I've witnessed her with a very bloodshot eye when it was hemorrhaging. I've witnessed her immediately beginning to cough upon the approach of a vaxed person. I also know several people whose family members received the injections while they, themselves, did not. Every one of them has had more than one illness, or developed a condition they'd never had before. Because of what I have directly witnessed, I firmly attest that their illnesses were due to the proximity of the injected, shedding relative inside the home.

As for myself, there are circumstances that make it difficult to identify or pinpoint my symptoms, because I live in a seniors' community with 44 other people; that is, I am in very close proximity to 44 people around the clock 365 days a year, far unlike in the average family. And the elderly population being even more fearful

of illness than the generations younger, I saw my neighbors flocking to get their shots and every booster, and so I am literally surrounded 24/7 by ever present horizontal transmission. Thus, I feel approximately the same all the time; that is, there is so much shedding at home that I can't discern much difference at the grocery store and small gatherings or public places. What I feel all the time is ever-present dizziness, and sleep disruption with resulting exhaustion and prostration. There are a couple of isolated incidents which I can identify clearly as being the result of exposure to shedding. First, in late 2023 I had a 2 1/2 month bout with a seeping eye infection. I was then 79 years old and had never had an eye infection. Pinkeye is generally known to heal within a week or two, and 10 weeks is rare; thus, my direct experience is that this infection was the result of covid vax shedding. Then a very standout incident was a birthday party for my cousin's husband, at which there were at least 60 guests present. I recall becoming dizzier and dizzier as the afternoon wore on, and being glad I was seated most of the time. By my departure time I had to hold onto the chair to avoid collapsing when I stood up, and to concentrate very intensely as I walked to my car. Fortunately, I was seated again in the car, and it was easier to drive than stand up. Another rather dramatic incident was at a meeting, sitting next to a neighbor who was discussing health insurance possibilities with a visiting agent, and I instantly began to cough. This neighbor had just taken the most recent covid shot, along with several other preventive vaccines due to an unbelievable list of health disruptions all at once. My throat irritation was so intense that I couldn't stop coughing and had to interrupt to ask my very quick question so I could leave. Just 3-4 minutes after departing the scene, my coughing stopped; therefore, I attest that I was directly experiencing the toxic shedding from the person next to me, who was heavily vaccinated with all the covid shots, plus several other vaccines.

Vaccine injury testimony

My father was a chiropractor and did not believe in vaccinating his children. We believed that the body can heal itself without the aid of man-made substances. Therefore, when COVID-19 was introduced to the world in 2021 I chose not to participate in the vaccine program. I was working in a physician's office at the time but was not required to get the mRNA Covid 19 vaccine. There were 10 others in my office that did get the vaccine. As with many vaccines there is the possibility of transmission to others if in close contact soon after injection. (Consider children who get a chicken pox vaccine can prompt the development of shingles in adults.) I had asked each of them to inform me when they received their initial shot and further boosters since the vaccine did not work as advertised.

In early January 2023 three of my coworkers had their boosters on the same day. I was unaware and was in close contact with each of them. By this time the information regarding the danger of spike proteins was available to everyone.

Around the 2nd week in January, about a week after my exposure, I had flu-like symptoms. A sore throat, high fever, body aches, and sinus infection. I was home in bed for almost 10 days. I treated with rest, vitamins, ivermectin and hydroxychloroquine. I was still weak and run down when I went back to work.

About 2-3 weeks later in February 2023 I was sick again only this time it was worse. My fever reached 103 degrees. I was diaphoretic, nauseated, very weak and short of breath. This time I did add in an antibiotic along with higher doses of Vitamin C, quercetin, and mullein leaf extract to help my breathing. I recovered but was left more weak and tired than ever before and my breathing was constantly impaired. I was also experiencing heart palpitations at this time. These are all symptoms of myocarditis that is a known injury of the Covid 19 vaccine.

It is important to note that my medical history included: cancer in 1981 and in 1991, open heart bypass and heart valve replacement surgery in 2016, and a pacemaker in 2016. The heart surgery was necessary due to the damage done with the chemo and radiation therapies. I recovered fully with my ejection fraction in the normal range.

My recovery from this illness was not complete when I resumed normal daily living. And then in March of 2023 I was sick again with intense Covid symptoms. After seeing a cardiologist in April of 2023 and performing a number of tests, it was determined that my ejection fraction was very low and I was in complete heart failure. My heart was only working because of the pacemaker.

I was treated with a new medication along with the blood thinner in hopes that my heart muscle would recover with rest and time. That did not happen and in April 2024 I had a new 3 lead pacemaker inserted.

I worked hard to recover with an organic diet, vitamin therapy, exercise dance classes and rest. I recovered quickly after that but have been left with a weakened immune system, a weak heart, and more susceptibility to future infections.

In addition I support the claim that was submitted by Keith Mauger.

My husband presented to the ER with symptoms of a stroke 6 months after his 3rd vaccine having no family history of stroke or vascular issues. This is the account to the best of my recollection:

Late morning On Monday August the 28th Jeff called me from work complaining of difficulty seeing weakness in his left leg left arm and difficulty verbalizing. From his work we drove to Diley Ridge ER. My instinct was to pray. I heard the words "just trust me." Remembering this is the time of the year when the king is in the field, and feeling His nearness a peace came over me. God's power and presence was real.

Jeff was in a room right away with a care team. As the doctor walked in, I couldn't see him through the crowd nurses and technicians surrounding him. Then I heard a familiar voice "Hi I'm Dr. Gora." I jumped to my feet to see a familiar face and to express my gratitude having been given a doctor I trusted which was a main concern. I had worked with Dr. Gora 20 years prior in the emergency room.

Upon examination the doctor conclude his symptoms likely were caused by a blood clot in his brain. Within minutes, Jeff was in the CT room. The doctor had ordered a CAT scan of his head and wanted to talk about clotbusting drugs to break up the clot causing these neurological symptoms.

I'm familiar with these protocols from administering them as a ER nurse. I knew the seriousness and potential side effects of these medications. The pressure was on. The doctor walked me back to the CAT scan room to make a decision. There are on the table just lying on his back with his head in the CT machine. Jeff looked up at me. I was on one side of the table. The doctor was on the other. Dr Gora indicated great urgency in the need to make a decision as time was of the essences. Dr did a final neuro exam to confirm Jeff's condition only to find the weakness completely subsided in both his leg and his arm. Jeff now was able to hold up his leg and his arm and his grip was strong. As we left the CT room, Dr. Gora said, "well now the risk outweighs the benefits". I was ecstatic.

The next two days were challenging as we agreed with hesitation for him to be admitted for 24 hour observation only to find a 48 hour stay documentation in his my chart. It was at a wrestling match to get him out of there in the agreed up 24 hour period. In the weeks and months following the incident we were faced with a \$10,000 hospital bill and harassed by collectors for an agreement to pay up within the year. Jeff felt pressured to borrow money to pay the balance.

Praise be to God for Jeff's healing. He is able to work to help pay off the medical expenses.
