**Common Law (‘Law of Mankind’):** The historically known system of God’s law all the way back to including, and preceding the Magna Carta and it’s associated like-minded documents. All express the will and intent of the living man/woman toward the greater good of mankind. NOT CODES AND STATUTES OF DEAD CORPORATE ENTITIES (“citizen”, “person” etc.).

**Peer:** one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.
