- a. **Treasury.** Keith: Postage for Fairfield County claim documents to be posted to the Summit County Court of \$21.95. Ross reports postage for his claim related to Walton Hills/Garfield Heights. *The annual summary of accounting for The Ohio State Jural Assembly* was completed and emailed for inclusion in the State Archival Records last week. There will soon be a page on the website where this information will be publicly viewable called: FINANCIAL TRANSPARENCY. The general assembly should decide and note for the permanent record how often this document is to be updated (suggestion: quarterly, just after each quarterly face-to-face get together).

Reminder: Expenses directly related to conducting the business of the Assembly NEED to be reported in writing to the Treasurer for inclusion in the public accounting report, *whether the member is seeking reimbursement or not.*

As we grow, the transparency of this process may come into question if we are not meticulous in recording, for example, real value of donated spaces to accommodate drastically larger groups or weekend events, such as that which the North Carolina Assembly is already periodically hosting. It IS reasonable to anticipate that Ohio will have the same, if not greater, interest in the near future as we continue to achieve publicized successes.
