**Common Law (‘Law of Mankind’):** The historically understood system of God’s law all the way back to, including and preceding the Magna Carta and all its associated, like-minded documents. All express the will and intent of The People (the living (wo)man on the land) toward the greater good of all mankind. **Today's discussion:**

- I. **(Texas) Employer overstep – violation of the right to fair compensation/foreign interference into contract between Matthew and Keith.**
  - a. Income tax claim against an employer's payroll/legal department is discussed. After an offer of simple notification of request to review evidence and potentially verify claim by the Grand Jury to the other parties involved, it is reemphasized that 'the procedure' is whatever the claimant, (in this case, Keith), decides is the best path forward.
- II. **Clarification of standing of the (wo)man when utilizing different forms of communication.**
  - a. Example is given of the email response received by Beverly from the Clerk of Courts of Garfield Heights. Aspects of the man, Alex Grgat's, response are examined.
  - b. Key factors
    - i. denial of free access to court, (request was made in advance for the security to apply non-electronic and non-irradiating procedures to assure the (wo)man was no threat to anyone on the premises. Alex Grgat refused on behalf of the Sheriffs deputies assigned at 'his' courthouse for this task. He instead insisted that a doctor's note be provided 'for this exception';

- ii. forced relinquishment of HIPPA rights, even after lengthy discussion illuminating that it is, in fact, the irradiation and horizontal transmission of mRNA components onto the healthy (wo)man making the request that is, in fact, the problem to be avoided;
- iii. prior experience with instant detrimental physical effects of current courthouses around Ohio, using various procedures **except** physical frisking and visual examination by living (wo)man;
- iv. all jurists present at this meeting (constituting the Board of Review) formally agree that Beverly and Anita were denied their rightful access to the public court hearing at the Garfield Heights Courthouse on December 5, 2025. (see recording for official vote tally).

III. **Update on Traffic Accident witnessed during the 12/ OSJA Business Meeting.**

- a. Michael desires to peacefully resolve his interaction with the man, Brodie, who operated his car while under the influence. Although he knocked the phone out of Michael's hand and shattered it, Michael gives major consideration for Brodie's engineering career (<https://www.linkedin.com/in/brody-frost-96019898/>) and how a DUI between himself and the Mack truck he hit will play out with his employer, the government, the trucking corporation and insurance companies are primary to Michael.
