This training is designed to educate all men and women on the land in ways to retain sovereignty, become self-governing, embrace common law and the traditional morals and ethics where every man and woman has equal Right AND Responsibility toward themselves and all mankind.

The foundation of this is that there are only two laws given purely by God to mankind – do no harm and do not trespass.

Our purpose here is to maintain continuity of OSJA, practice and prepare for common law activities; these ‘minutes’ act as the active component of the Ohio State Jural Assembly jurist training ‘handbook’ by application(s).

Common Law (‘Law of Mankind’): The historically known system of God’s law all the way back to including, and preceding the Magna Carta and it’s associated like-minded documents. All express the will and intent of the living man/woman toward the greater good of mankind. NOT CODES AND STATUTES OF DEAD CORPORATE ENTITIES (“citizen”, “person” etc.).

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

Today's discussion

- I. **Walton Hills / Garfield Heights Traffic Cam Scam.** Ross updates on the unlawful unmanned traffic cam scam. Recording of the exchange is played, discussion ensues.
 - a. **Access to the public courts.** Beverly discusses the matter she and Anita brought before the Garfield Heights Clerk of Courts regarding the blackmail extortion of being required to submit to physical harm in order to be present as a living (wo)man, even to witness at a court hearing.
 - i. That the only option seen by The Court is to participate as an electronic image via Zoom recording if one refuses to submit to the radiological damaging devices or horizontal shedding transmissions is explored at length.
- II. **Lysander Spooner.** Further to the initial book utilized in our Grand Jury study process, other comparable essayists are brought to light in the conversation about a recent opportunity Michael has before him with antique books, including Encyclopedia Brittanica from 1892.
