from: i: the woman; cristina marni delia; do present notice of claim of trespass by harm against the woman: sadie sutton; i, state that: on september 9, 2022, the woman; sadie sutton act with malicious intent to cause extreme emotional distress and mental anguish, harass, terrorize, attempt grand theft, and false imprison and hold i; hostage, verifiable with video surveillance footage from Radisson corporation by the woman: denise litten, the woman: shelly irrgang, the woman: nancy johnson or their agents;

i state that: the woman; sadie sutton did menace through her agents and employees, self, and men who sometimes act as chief of police or police officers for macedonia police department, at or around and between 8:00 am to 1:00 pm on September 9, 2022 at the franchise location of radisson country inn and suites, 7820 capitol boulevard, macedonia, ohio;

notice that i: the woman; cristina marni delia, a sentient moral being, have provided three acts of repentance correspondence, attached, offering remedy for settlement to the woman: sadie sutton for harms caused by i: the woman, cristina marni delia, with no response;

i state that: silence of the woman: sadie sutton in the matter of restitution, remedy and settlement in any and all forms by i: the woman, cristina marni delia does constitute tacit agreement by the woman: sadie sutton that there exist no harm nor trespass done upon the woman: sadie sutton by i;

that said, i: require remedy of trespass by harm through tortious interference, malicious inflict of extreme emotional distress and mental anguish, cruel and unusual punishment, harass, terrorize, attempt grand theft, false imprison, slander, libel, perjury, blackmail, and barratry done on i: the woman, cristina marni delia, my property, and those in the care of i by the woman: sadie sutton;

i state: if the woman: sadie sutton: fails to issue to all local newspaper and social media outlets a sworn notarized statement to retract any and all fraudulently issued statements and testimony related to i: the woman, cristina marni delia to correct the public record and clear the reputation of i; provide remedy for trespass by harm against i: the woman, cristina marni delia which has cause the expense of office supplies, postage, and fuel in the amount of \$500; 42 days loss of work at \$300 per hour equaling \$101,300, payable to i in troy ounces of pure silver, within 30 days of receipt of this notice of claim, there will commence increased accumulating expense at 12:00:00 a.m. on November 11, 2022 of \$1.00 per second, for each second the trespass is not remedied by the woman: sadie sutton, which claim will be then entered for immediate adjudication plus additional expense of lost work time and fuel.
