i, state that: dave yost, frank larose, john clark, STOW BAILIFF, STOW COP, amber zibritosky, nicolas molnar, santo thomas incorvaia, myra staresina severyn, mark guidetti, jon golden, annette smith, jason hetrick, maxwell bacher, steven russell, daniel l matejka, and bryan vince are bound by oath as public servants with duties and obligations to protect and uphold the god given rights of i, the woman, for the betterment of mankind to include the person and property of i: a living woman;

i, state that: pursuit of fraudulent criminal charges and unlawful confiscation of personal properties do violations of due process of i; cause harms to the person and property of i, and do harms to others in the care of i;

i, state that: it comes to the attention of i, that, john clark, amber zibritosky, mark guidetti, santo thomas incorvaia, myra staresina severyn, and annette smith make claim that i, owe a debt toward case CR B 00201, which was discharged by the offer of the woman, myra staresina severyn, in her private office at or about 12:55 p.m. on September 15, 2022 prior to hearing, the written acceptance of the offer by i, the living woman, cristina marni delia, written and spoken onto the record in open macedonia mayors court hearing, and approved with verbal and written acknowledgments of the offer by both the woman; myra staresina severyn and the man; santo thomas incorvaia in open court at macedonia, ohio at or about 1:18 p.m. on September 15, 2022,

i, state that: it is the intent of john clark, amber zibritosky, mark guidetti, santo thomas incorvaia, myra staresina severyn, and annette smith to cause theft and trespass by harm through retention of stolen property of i; refusal to accept entry of statement true fact by i onto the court record of firsthand evidence of the event; refusal to make whole i on vandalism committed against the property of i; continued pursuit of i on the discharged case using harassment and threats of slanderous libel, menacing stalking, blackmail, unlawful imprisonment and theft of property against i; and do harms to others in the care of i;

i state that: this intention is knowingly, intelligently and willfully entered by speech into the public record in open macedonia mayor's court at about 1:22 p.m. on September 15, 2022 by santo thomas incorvaia practicing law from the bench, fraudulently entering a plea on behalf of i: the living woman, cristina marni delia; when confronted by i, the man; santo thomas incorvaia did then threaten to further criminally charge and hold i: the woman falsely in contempt of court on unsubstantiated nonspecific contempt claim;

i state that: the man: john clark, on October 7, 2022 at around 1:25 p.m. did knowingly, intelligently, and willfully enter by speech into the public record in open stow municipal court acknowledgement that i: the woman, cristina marni delia appeared present only by special appearance to remedy and settle same matter; the man; john clark did ignore offer of remedy and settlement, instead practicing law from the bench, did fraudulently enter a plea on behalf of i: the living woman, cristina marni delia; when confronted by i on this, the man; john clark, did instruct his agents to menace and threaten physically and with weaponage force me out of the public accommodation courtroom;

i, state and repeat that: i acknowledge the woman; sadie sutton, may have, during the course of the period beginning around 1:00 p.m, september 8, 2022 through 11:26 a.m. september 9, 2022, at the location of **Radisson Country Inn and Suites**, macedonia, ohio had occasion,

in response to her repeated and continued badgering harassment with intent to commit false imprisonment and grand larceny against i,

where she herself and through her agents intentionally and with malicious intent did escalate multiple times in video surveilled areas of the hotel over a period of some hours between 8 am and 11:26 am on september 9, 2022,

to recognize that the woman; sadie sutton may have set herself up to feel or perceive that i clearly understood her malicious and unlawful intents against i;

that i felt sufficient threat from her against freedom, body and property of i, that i was forced to respond to these repeated and escalated threats and take reasonable lawful measures to protect i and my property from further increased attacks by the woman; sadie sutton, by retrieving and carrying my lawful held personal protection device to escape the woman; sadie sutton and her attempts to physical injure, grand theft and false imprisonment of i;

that said, i, require remedy, and i, have offered request for remedy three times from the woman; sadie sutton to make her whole by letters dated september 14, 21, and 28, 2022;

i, state that if a verifiable claim for a debt does exist by a man or a woman at this time by i: the woman; cristina marni delia; that i, have \$10.00 per month to pay toward said debt till paid in full without interest; however, any amount more than that will cause i, grievous harm and harm to those in the care of i;

i, ask; is there anything else of value you will accept for payment of a debt that you:

- 1 claim is true;
- 2 believe i, owe to you; mister or missus state of ohio, mister or missus summit county, mister or missus macedonia ohio, mister or missus stow ohio, frank larose, dave yost, john clark, amber zibritosky, nicolas molnar, santo thomas incorvaia, myra staresina severyn, mark guidetti, jon golden, annette smith, jason hetrick, maxwell bacher, steven russell, daniel l matejka, bryan vince, sadie sutton;

however, that said:

if continued tortious interference, intentional infliction of emotional distress and mental anguish, harassment, slander, assault, unlawful imprisonment, kidnapping, libel, theft by illegal search and seizure, cruel and unusual punishment, blackmail and all other forms and variations of barratry continue by any man or woman against i beyond 30 days from the date of receipt of original notification of September 20, 2022 correspondence,

should every charge against i not be expunged, personal property not returned, vehicular vandalism not repaired to the restorative satisfaction or appropriate compensation to affect such damage correction not be made to i, written public press release apologies from each man and woman identified here not be published in every local newspaper and official social media website to correct the public record of i: the woman, cristina marni delia,

i, consider that to be trespass by way of malicious persecution with intent to harm, tortious interference, intentional infliction of emotional distress and mental anguish, harassment, slander, assault, false imprisonment, kidnapping, libel, theft by illegal search and seizure, cruel and unusual punishment, unlawful prosecution, blackmail and barratry; and i, would seek the principal value of \$750,000.00 plus \$1.00 per second, remittable in 99.99% pure gold to i: the woman, cristina marni delia so long as the trespass continues beyond 12:00:00 am october 21, 2022 from each: frank larose, dave yost, nicolas molnar, john clark, amber zibritosky, santo thomas incorvaia, myra staresina severyn, mark guidetti, jon golden, annette smith, jason hetrick, maxwell bacher, steven russell, daniel l matejka, bryan vince and sadie sutton;
