i, state that: dave yost, frank larose, kim hoover, john clark, amber zibritosky, nicolas molnar, santo thomas incorvaia, myra stakesina severyn, mark guidetti, jon golden, annette smith, jason hetrick, maxwell bacher, steven russell, daniel l matejka, and bryan vince are bound by oath as public servants with duties and obligations to protect and uphold the god given rights of i, the woman; for the betterment of mankind to include the property of i: a woman;

i, state that: extortion, continuation of malicious pursuit of discharge case; retain of stolen property; retain of ransom monies; tortious interference; intentional infliction of emotional distress and mental anguish; menacing; stalking; harassment; slander; assault; unlawful detainment; kidnapping; libel; theft by illegal search and seizure; cruel and unusual punishment; blackmail; and barratry do trespass by harm and violation of due process of i; cause harms to the person and property of i; and do harms to others in the care of i;

i state that: trespass by harm by extortion; kidnapping; blackmail; slanderous libel by false charge of theft; and barratry by BLONDE GIRL WHO TOOK ROSS' CASH committing forgery of mayor nicolas molnar autograph do trespass by harm against i: the woman, cristina marni delia, and those in the care of i, in the amount of \$525.00 ransom in US dollars cash, copy attached;

i state that: it comes to the attention of i, that, kim hoover, john clark, amber zibritosky, mark guidetti, santo thomas incorvaia, myra stakesina severyn, annette smith, make claim that i, owe a debt toward case CR B 00201 which result in forfeit of properties and monies of i as stated by the man: john clark;

i state that: settlement offer volunteered by the woman: myra stakesina severyn, in her private office at or about 12:55 p.m. on September 15, 2022 prior to hearing, the written acceptance of the offer by i, the woman, cristina marni delia, written and spoken onto the record at open macedonia mayors court, and approved accepted with verbal and written acknowledgments of the offer by the woman; myra stakesina severyn and the man; santo thomas incorvaia at open court at macedonia, ohio at or about 1:18 p.m. on September 15, 2022 did lawfully discharge case CR B 00201;

i ask: is it the intent of, kim hoover, john clark, amber zibritosky, mark guidetti, santo thomas incorvaia, myra stakesina severyn, annette smith, mister or missus state of ohio, mister or missus summit county, mister or missus macedonia, ohio, and mister or missus stow ohio, to cause theft and trespass by harm through continued pursuit of slanderous libel, retain stolen property of i; to refuse accept entry of affirmation of true fact by i onto court record as firsthand evidence of the event; to refuse to make whole i on theft of ransom against the property of i; to refuse to make whole i on vandalism against the property of i; to continue pursuit of i on discharge case using harassment, slanderous libel, menacing, stalking, blackmail, unlawful detainment, vandalism and theft of property against i; and do harms to others in the care of i;

i state that: this intention knowingly, intelligently, and willfully is enter by speech onto public record at macedonia mayor's court at about 1:22 p.m. on September 15, 2022 by santo thomas incorvaia who did practice law from the bench, enter a plea on behalf of i after written settlement and acceptance by i: the woman, cristina marni delia; when confront by i, the man; santo thomas incorvaia threaten to further criminally charge and hold i: the woman falsely in contempt of court with unlawful detainment on unsubstantiated nonspecific contempt claim based upon no harm to man nor woman by i;

i state that: the man: john clark, on October 7, 2022 at around 1:25 p.m. knowingly, intelligently, and willfully enter by speech onto the public record at stow municipal court acknowledgment that i: the woman, cristina marni delia appear present only by special appearance to remedy and settle; the man; john clark refuse to acknowledge offer of remedy and settle, instead practice law from the bench, enter plea on behalf of i: the woman to continue extortion,

blackmail, harassment, slander, libel, menacing, stalking, unlawful detainment, vandalism and theft of property against i; when confront by i, the man; john clark, loudly order FAT COP AND BAILIFF, to menace, threaten physically and with weapons force i out of courtroom and further intimidate, menace, stalking, harassment, and threaten further unlawful detainment of i;

i, state and repeat that: i offer now three times remedy restitution compensation to make whole to the woman; sadie sutton, with humble repentant acknowledgement of any all perceive harm, debt, trespass or wrong against the woman: sadie sutton by i, during the period beginning around 1:00 p.m, september 8, 2022 through 1:00 p.m. september 9, 2022, at the location of **Radisson Country Inn and Suites**, macedonia, ohio,

that said, i: require remedy in that i: in honor, to eliminate controversy, do offer request for remedy three times from the woman; sadie sutton to make her whole by separate correspondences: september 14, 21, and 28, 2022, with no response;

i state that: interference of kim hoover; john clark; amber zibritosky; nicolas molnar; santo thomas incorvaia; myra stakesina severyn; mark guidetti; jon golden; annette smith; jason hetrick; maxwell bacher; steven russell; daniel l matejka; bryan vince do trespass by harm by prevent peaceful return to honor by i and the woman: sadie sutton;

i state that: remedy of trespass by harm by prevent return to honor of \$500,000 from each: frank larose, dave yost, kim hoover, john clark, amber zibritosky, nicolas molnar, santo thomas incorvaia, myra steresina severyn, mark guidetti, jon golden, annette smith, jason hetrick, maxwell bacher, steven russell, daniel matejka, and bryan vince is required;

i state that: if verifiable claim for a debt, wrong, harm, or trespass does exist to a man or a woman at this time by i: the woman; cristina marni delia; that i, have \$10.00 per month to pay toward said debt until paid in full without interest; however, any amount more than that will cause i, harm and harm to those in the care of i;

i, ask; is there anything else of value you will accept for payment of a debt, wrong, harm or trespass that you:

- 2 believe i, owe to you; frank larose, dave yost, kim hoover, john clark, amber zibritosky, nicolas molnar, santo thomas incorvaia, myra stakesina severyn, mark guidetti, jon golden, annette smith, jason hetrick, maxwell bacher, steven russell, daniel l matejka, bryan vince, sadie sutton;

however, that said:

if continue extortion, malicious pursuit of discharge case, retain of stolen property, retain of ransom, tortious interference, intentional infliction of emotional distress and mental anguish, menacing, stalking, harassment, slander, assault, unlawful detainment, kidnapping, libel, theft by illegal search and seizure, cruel and unusual punishment, blackmail and all other forms and variations of barratry continue by any man or woman against i beyond 14 days from the date of receipt of original notification of September 20, 2022 correspondence,

should:

- o every charge against i not be expunge,
- o personal property not be return,
- o compensation to correct malicious destruction of property of i by way of intentional vehicular vandalism damage to custom paint and chrome, to replace and correct not be made to i in the amount of \$15,000,
