## **Today's discussion:**

### **I. Review of correspondence**

- a. Notice to Alex Grgat in response to his refusal to provide safe entry and access to public court. Many particulars of language manipulation usurping jurisdiction by him are rebutted. Further helpful explanation to the man regarding harmfulness of horizontal shedding is made in an attempt to restore him to honor, as his statements repeatedly stand on his defense of court employee's HIPPA rights but at the same time he insists that anyone requesting a return to pat-down (non-emf/radiation) security must provide a diagnostic note from a state licensed medical professional.
- b. Anthony Pena might provide insight for us into this specific thread.
- c. Each County Clerk of Courts who has refused to grant access to a lawful court of record should receive a similar Notice since it is a Constitutionally protected right.
- d. Regional Grand Jury Board of Review is further discussed.
- e. Badwolf is proposed as a speaker before the Grand Jury on several topics. It is unanimously agreed that we should pursue this opportunity.
- f. It is pointed out that Alex Grgat, Garfield Heights Clerk of Courts, seems to be open to dialogue with us.

**II. Notice to Brandon Meyer is discussed – the Claim being focused on NOW is denial of access to court.**

- a. Hand deliver or send via Registered Mail to confirm receipt since Brandon is ignoring all correspondence.
  - i. Each man/woman who receives any correspondence must be addressed by name. Ask, again, that the document be time-stamped.
  - ii. Take witnesses, stand on our refusal to be irradiated, etc.
  - iii. Utilize Garfield Heights Court to docket correspondences as well as Summit County.

**III. Kat verifies Beverly's claim on horizontal shedding symptoms on September 20, 2023 in Delaware, Ohio**

**IV. Michael discusses his Ecclesia contact coming on our Saturday call.**

- a. Jim, who might also give us greater insight into holding a proper court would want us to watch several of his Monday night calls prior to coming to talk to us.
  - i. Shopyourfarm.com is their website, recordings are currently not publicly viewable until after you pay the monthly membership fee (\$13?).
- b. The issue of gatekeeping critical information in exchange for money is revisited.
  - i. **National Driver License** and **Land Patents** [https://youtu.be/H\\_WnkEAPKn8?si=dva6fDw\\_yhlOuNpZ](https://youtu.be/H_WnkEAPKn8?si=dva6fDw_yhlOuNpZ) are brought up as two of the topics that we know to be of extreme interest to our membership and audience, so compensating Badwolf 'a token' in exchange for this knowledge is well within reason.

**V. Alisha Landis** speaks to the issue of a highly aware vaccinated person who IS clear on the detrimental effects of the nanotechnology and how difficult it is to hear us "giving up on helping her and people like her".

- a. The group is immediately clarifying that she is such a rarity, we, unfortunately, primarily focus on helping the next most important group, that which (for now) we belong to – those who are trying to maintain our non-vaxxed status.
- b. It is the sincere hope of every member of the Assembly that by sharing Alisha's desire to unite with others who have overcome the nanotechnology-control aspect in their hearts/minds/souls, we might at a minimum act as intermediary for those people trying to find each other.
- c. Our desire to heal mankind and peacefully restore psychological and spiritual sovereignty as it was endowed upon us by The Creator to as many man and woman on Earth as we possibly can, by every means available to us.
