Motion to Amend the OSJA Bylaws to add, under **Primary Functions** - "*Functions and Operations of the Grand Jury*"

### MISSION:

### PURPOSE:

once 66 of the 88 counties' delegates are regularly attending 'State Business Meetings', the notation (PURPOSE – i. ) for maintaining continuity of the State Committee of Safety, shall be voided, as having become moot.

Vote to accept the motion to formalize the operations and procedures of the Grand Jury within the OSJA Bylaws;

Cristina Motions, Beverly and Keith Second;

Abstain - 0, No - 0, Yea - 9.

The motion carries unanimously and shall be implemented and incorporated onto the record and within the Bylaws immediately.

Here ends the OSJA Business portion of today's meeting.

If a clerk refuses a document, **you can file a petition with the court for an order to compel acceptance**, but clerks generally can't reject filings solely for minor formatting issues, though they can flag non-compliance for correction.

#### **Reasons a Clerk Might Refuse a Document**

Not Required: The document isn't something that should be filed with that specific court.

Fraudulent: The clerk has reasonable cause to believe the document is materially false or fraudulent.

Vexatious Litigator: For county courts, a clerk can refuse filings from someone declared a vexatious litigator without court leave (ORC 1907.20).

Improperly Filed: Documents like depositions or interrogatories might be rejected if not filed under court order or for use as evidence (local rules may vary)

Ask for the Reason: Inquire why the document was refused and **request a formal "notice of refusal" form.**

Correct the Document: Address the issue (e.g., add missing info, fix formatting).

File a Petition: If the refusal seems improper, **you can petition the court (like filing a writ of mandamus) to order the clerk to accept it.**

Court Review: The court will decide if the document should be accepted for filing.

Federal vs. State Rules: Federal courts often have stricter rules preventing clerks from rejecting based only on form, requiring court referral instead, but Ohio state courts have specific provisions (ORC 2701.20) allowing refusal for specific reasons
