PURPOSE:

 - claim evaluation;
 - evidence gathering and review;
 - certification (or rejection) of claim validity;
 - presentment of same to magistrate/clerks of courts/sheriff for lawful execution of remedy.
- ii. Each step of the process to be effected according to the principles outlined in the Ohio State Jural Assembly Covenant of Office.

Weekly summary notes are to act as the archival record and active component of the Ohio State Jural Assembly jurist training 'handbook' by application(s).

Common Law ('Law of Mankind'): The historically understood system of God's law all the way back to, including and preceding the Magna Carta and all its associated, like-minded documents. All express the will and intent of The People (the living (wo)man on the land) toward the greater good of all mankind. **THIS SYSTEM REJECTS CODES/STATUTES OF DEAD 'CORPORATE' ENTITIES** and all language associated with same (citizen, person, employee, sir/ma'am, all titles of nobility, etc.)

Peer: one who shares sufficiently similar knowledge and experience as the bringer of the claim such that they can be considered like-minded to an extent where fair and equitable evaluation and adjudication can be reasonably expected.

Important details not written here can be gleaned from viewing the video recording.

Today's discussion:

I. Keith updates on his recent successful notice to the man (compensation)

- a. Second notice was drafted in the last week, based on the stonewall response from the corporation's general counsel (attorney) out of Texas. This will not be needed, as Keith received his recent compensation **WITHOUT TAXES REMOVED**.
- b. Keith notes that there were a series of documents he had submitted to various entities including the payroll department that set the stage for his insistence on taking back responsibility and decision making authority for himself regarding income taxes. He is going to work on a summary document to be posted on the website detailing this process.

II. Demand for Court notice to all 88 County Clerks of Courts on Ohio.

- a. Discussion on the mechanics of getting the documents delivered to every County Clerk of Courts is had, including the amount of time to allow between receipt of the notice and the second notice acknowledging their silence as consent that they do not have a lawful court to offer.

III. Cell (5G) Tower ownership

- a. How to determine ownership of our local cell towers is discussed. It is recommended that we query who, how, and WHY these cell towers are being utilized on the path to insisting on their removal.

IV. Zoning and Regulation of private residential properties

- i. Sanitary sewer / septic tank matters as well as rental versus land contract concerns are discussed. Common law versus codes/statutes language, strategies and ideas are considered.
- ii. Potential trespass harm intent by a (commercial) neighbor who seems to be trying to weaponize local Zoning Inspector matter is raised for group input. Commercial property is

in violation of their zoning obligation to maintain privacy fencing between their parking lot and neighboring residential properties, yet the zoning inspector is attempting to force contract allowing his jurisdiction onto the private land because commercial neighbor claims a seed-starting cold frame “is a public eyesore”. This gardening endeavor would not be visible if the commercial properties had any fencing or evergreen shrub privacy screening. Conversations have been had, follow up summary documents are drafted and will be mailed out putting the zoning inspector on notice to show cause to interject himself onto the private.

V. Procedural/Documentation

- a. Grand Jury document labels to achieve positive supporting acts from Constitutionally compliant Sheriff/Clerk of Courts are discussed. Homework : research and report required.

Encouraging commentary from all members on the spiritual, psychological and knowledge-base improvement of our attendees is shared.
