- a. Michael brings up his concern over the areas of our Bylaws where he feels language perfection may be needed. Discussion regarding use of the potential controversial word ONLY in the phrases within the Bylaws "...two God-given laws..." is had. Motion is collectively drafted to read as follows:

MOTION: made by Michael; seconded by Keith;

It is proposed to change Bylaws language to remove the word "only" when referencing God's laws to say "...foundational truth *in* the two God-given laws - mankind shall do no harm and do no trespass" in the two places it now appears.

Vote : Nay – 0, Abstain – 0, Yea – 6;

The motion carries and shall be implemented and incorporated into the Bylaws immediately.
