Old Business

I. Previous meeting minutes

b. Education Chair

- i. Michael – he is still working on how to equitably set up our personal houses under God to have the strongest possible position to rebuff the de facto in their assumption they can treat us as incompetent children who need their rights to be re-administered by BAR, codes & statutes.
- ii. Ross brings up his recent response to Jeff Wensing, President of the Ohio Education Association where he instructs all public-school employees to obstruct ICE agents and their efforts on the grounds of public schools. Whether to post this exchange on the Education page of the website or on the Petitions page is discussed, as well as choice of language. It is mentioned that the goal ought to be to re-educate and inform this public representative that he is not, in fact, representing the public with this type of unlawful and illegal activity. Ross is encouraged to walk back his language to a less aggressive/abrasive tone and write a second notice requesting Mr. Wensing act as a positive role model by cooperating with Federal law enforcement personnel and operations.

c. Public Affairs Chair

- i. Cristina reports on recent conversation with Dr. Anthony Pena; he will be joining us on a Saturday call in the very near future (not this coming Saturday); will advise as soon as a definite date is settled upon.
- ii. Keith reports on the responses from a handful of Ohio clerks of courts as it relates to the same offices/officers who did not respond to the Constitutional Surveys sent out last year.

d. Grand Jury Commission Report

- i. Keith reports on behalf of our Grand Jury Commissioner, Beverly – Only four counties lower employees in Clerks of Courts offices from Montgomery, Ross, Guernsey and Ashland counties. All responses categorized the demand for court as a request under BAR rules for a Civil Complaint Case. Second notice needs to be drafted clarifying that they completely missed the point just like those clerks in Fairfield County did all along. Decisions need to be made on exactly how Keith should word his second notice to the 88 County Clerks of Courts who are responding via email to his recent Demand for Court (sent out via USPS 01 26 2026).
- ii. Beverly has drafted an invitation to our court addressed to the three Fairfield officials to attend OUR court.

Open New Business: Moved Keith; Seconded Cristina;

- **County Bilateral Social Compact to be a compilation** of North Carolina & Ohio state BSC and three county BSC's one from NC, from Fairfield County, Ohio and Macomb County, Michigan.
