For instance, a state legislature passing a law stating, "John Doe, Jane Smith, and Robert Johnson are hereby declared guilty of tax fraud and must each pay a fine of \$100,000," would be an unconstitutional bill of attainder. This law bypasses judicial process, targets identifiable individuals, and inflicts punishment without due process.

Another example involves a law targeting a clearly identifiable group: "All former executives of 'Global Investments Inc.' who served between 2018 and 2022 are permanently barred from holding any position in the financial industry and must forfeit all retirement benefits earned during that period." Though not naming individuals directly, this law punishes a specific group based on an implicit declaration of wrongdoing without individual trials, meeting the criteria of a bill of attainder.
