Our birth certificates set us to sail on the seas of commerce. We have been led to think we are the ALL CAPS NAME on our birth certificate, social security card and driver's license, but really that's just a boat, not us. It can be useful to have these vessels for navigating the current paradigm of the public realms. We are generally operating in public commercial jurisdiction, unless we rebut, or remember to choose otherwise. Maritime Law of public commerce is the lowest ranking jurisdiction of Water.

On the path of sovereignty it is important to remember that we are living men and women of the living soil of Earth, named by our kin. We inhabit the land, which is governed by Common Law, the Law of Man, in the jurisdiction of Land, descended from Natural Law or Universal Law. Ultimately, we and the Universe are governed by God's Law, also known as Ecclesiastical Law, which is the highest ranking jurisdiction of Air.

As we learn to choose which jurisdictions we'd like to play and work in, we can choose the vessels which best support our forays into commerce. I prefer to operate on the land, in the private, within a Private Membership Association (PMA), with a Private Express Trust as a vessel for interfacing with commercial institutions.

LLCs, S-corps, and C-corps, along with our "straw man" (ALL CAPS NAME), are all firmly anchored in the watery realms of public commerce, beholden to all of the obligations therein.

Ministry flies above the other vessels, spanning land and water, making it an excellent intermediary between the public and the private. Ministries can serve the people of the public without the usual obligations to the public realms incurred in commerce.

Private Express Trusts originate in Ecclesiastical Law jurisdiction, providing another excellent bridge between the public and the private.

The jurisdiction of Air becomes the ultimate conduit of sovereignty when we connect with Source Consciousness above (Father God) and below (Mother Earth), learn to stand in the integrity of the truth of who we are, and become emissaries of conscious awareness as sacred sovereign creators on planet Earth, for the benefit of all beings.

# Why Pay Income Tax?



The US financial system is built on debt. The national debt is generated by the use of the private reserve currency of the Federal Reserve central bank. Income tax is an indirect “excise tax” or “use tax” on private Federal Reserve Notes, also known as FRNs or “ferns,” and the IRS is the collection agency for the Fed. Income tax is simply an interest payment on the national debt.

Therefore, the only reason to pay income tax is in order to qualify for a home loan, also known as a mortgage. “Mortgage” is from French, meaning “death pledge.” The interest paid over the life of a home loan typically equals more than the total purchase price of the home, and it often takes the rest of one’s life to pay it off. It’s incredible that despite all of this, home ownership has remained one of the best ways to build financial security in the current paradigm.

If you already own a home there are other options for acquiring loans for additional properties, without tax returns. Hopefully, soon there will be crypto based options for everyone, regardless of tax records. Meanwhile, **if you’re ready to stop paying income tax**, check this out:

When the Federal Reserve Act of 1913 was passed, Congress kept the ability to print money while also granting the ability to the Fed. Fed Notes are assumed to be received as private credit (a debt note), unless objected to. US Bank Notes issued by Congress don’t incur a debt and therefore are tax exempt. This is known as “lawful money”. Redeeming and demanding lawful money excuses income tax liability. We’ve all heard by now that “taxes are voluntary,” well, this is how.

**The IRS is generally cooperative with 12 U.S. Code § 411 redeemers:** Keep records of all lawful money deposits. After a year of demanding and redeeming lawful money, file for a return of all tax withheld. When the IRS receives a 1040 form, from one who has been redeeming lawful money, and checks the bank records, a refund is given. The IRS sends back the withheld taxes and interest on those funds. Lawful money refunds can take 6-12 months.

SUBCHAPTER XII—FEDERAL RESERVE NOTES

**§ 411. Issuance to reserve banks; nature of obligation; redemption**

Federal reserve notes, to be issued at the discretion of the Board of Governors of the Federal Reserve System for the purpose of making advances to Federal reserve banks through the Federal reserve agents as hereinafter set forth and for no other purpose, are authorized. The said notes shall be obligations of the United States and shall be receivable by all national and member banks and Federal reserve banks and for all taxes, customs, and other public dues. They shall be redeemed in lawful money on demand at the Treasury Department of the United States, in the city of Washington, District of Columbia, or at any Federal Reserve bank.

**This strategy does not address Social Security and Medicare taxes**

# Lessons in Lawful Money

It's so simple, just choose US Bank Notes, which are not subject to income tax. Silence is acquiescence, so you must make your preference known on the record.

This is how to indorse a check for a personal account. It's best for the indorsement to be in red ink, but not mandatory. It's unlikely you'll encounter resistance from a bank teller, but if you do, just say "are you dishonoring the check?" They must honor your indorsement.

It is best to open a new bank account and stipulate that all incoming funds will be received as lawful money (definitely do this if you establish a Trust!). If you receive a paycheck, do everything you can to get an actual paper check - it is much easier to keep records that way.

If you can't get around receiving electronic payments online - go into the backend of your payment processor where your address is and type into the second address line "all funds received as lawful money". The point here is to HAVE IT ON RECORD that you are redeeming lawful money. Then if the IRS offers you an audit, you can clearly show them you don't owe.

**BONUS:** Redeeming lawful money decreases the national debt because US Notes cannot be used as reserve currency or used in fractional reserve lending. ✨

# Why Choose a PMA?

You may think you need to have a license to practice your craft, or sell your products. That is only true if you are serving the public in a regulated field. Within a **Private Membership Association** you can privately exchange goods, services and compensation within the membership by mutual agreement to do so.

PMAs create a clear container for delivering your offerings based on Common Law. PMAs are created with the elements of a contract, the limitation being that you cannot offer anything that presents a clear and present danger of substantive evil. Like, no fight clubs.

Ensure your offerings are life giving and generative, because according to Common Law, you would be responsible for making remedy if you directly cause harm. As people living on the land we choose to acknowledge the inherent risk of living, leave the litigious society, and take full responsibility for our creations, including making remedy when needed.

**We call it an agreement**, and avoid the use of the term contract, to stay lawful rather than legal. However, the elements of a contract would stand up in court, regardless of what they are called.

## **Elements of a Contract:**

- offer - I have something
- acceptance - you want it
- consideration - you choose to invest
- meeting of the minds - we agree to exchange
- competency & capacity - we are aware & capable
- identification of parties - our names are expressed

# My PMA Declaration and Agreement

My PMA (Association) and Member may be referred to individually as "Party" and collectively as "Parties". Hereinafter, "you" and other third-person pronouns will refer to Member and "we" will refer to the Parties.

### Recitals

**Whereas,** My PMA is designed for the following purpose: Name purpose here.

**Whereas,** Member would like to join My PMA and acknowledges and agrees to be bound by the terms and conditions listed herein;

**Now,** therefore in consideration of the promises and covenants contained herein, as well as good and valuable consideration of a 20 dollar lifetime membership fee (and/or monthly or annual subscription fee) (the receipt and sufficiency of which is hereby acknowledged), the Parties do agree as follows:

### Article 1 - Membership

This Agreement forms a binding agreement, in alignment with natural law, between Member and My PMA and governs the Member's access and use of the Association's services (the "Membership Services") and physical facilities, wherever we may gather (or location if applicable). This Agreement also covers the Associations's provision of services (the "Membership Services").

In the container of **My PMA** we recognize and honor that **healing arises from within**. The **remedies, medicines and practices we utilize offer a stimulus to the innate power of healing that resides in each of us**. Entering into this agreement, you claim your right to manage your **health** how you choose. You take full responsibility for your choices and outcomes. **This path offers an opportunity to deepen your intuition, and requires a degree of self-tracking**. You acknowledge the relational nature of this path and the benefit of ongoing engagement. You agree to monitor your processes and progress, and consult with Your Name as needed.

You understand that **My Name** provides services, care and products in the capacity of a fellow member of **My PMA** and not in the capacity of a **licensed health care provider**. You affirm that you do not represent any state or federal agency whose purpose is to regulate **the practice of medicine**.

**\*By accessing any of the membership Services, you agree to be bound and abide by this Agreement and any Amendments thereto. Read this agreement carefully before using any of the Membership Services, because it limits your legal right to bring a lawsuit or class action. If you do not agree to these terms, please immediately cease use of any Membership Services.\***

## **Article 2 - Membership Services**

The Membership Services provided by **My PMA** are as follows: **List services here**.

## **Article 4 - Member Agreements**

Member agrees to hold **My PMA, its consultants, facilitators**, and members harmless from any damage, tangible or intangible, that may happen to Member while participating in the Membership services.

Member agrees that **My PMA** offers its membership and services with no guarantee of results of any kind. Member agrees that any results that occur during their membership, whether positive or negative, are the effects of Member's own personal choices.

Member agrees and verifies that all of the information they have given **My PMA** and its representatives is accurate, up to date, and without the omission of any requested information. Member agrees and verifies that even if they have omitted any necessary personal information, whether knowingly or unknowingly, they will hold **My PMA** harmless against all liability for any damages that may occur to Member or others because of Member's actions or inactions.

### **Article 5 - Dispute Resolution**

In case of a dispute between the Parties relating to or arising out of this Agreement, the Parties shall first attempt to resolve the dispute, member to member, in good faith. We shall embody self-responsibility and compassion to find our way to shared reality and to make remedy if needed. If we need the support of a private mediator, then we shall hire one and split the cost equally. Under no circumstances shall we enter into a legal court to attempt resolution. The courts shall have no authority to add Parties, vary the provisions of this Agreement, award punitive damages, or certify a class.

### **Article 6 - Termination**

This Membership shall continue until terminated in writing by either Party. This Agreement may also be immediately terminated in the event that there is a breach of the terms of this agreement by either Party. This Agreement will also immediately terminate upon the death of the Member, the liquidation, dissolution or discontinuance of the Association by the Association in any manner, or the filing of any petition by or against the Association.

### **Article 7 - Entire Agreement**

This Agreement constitutes the entire understanding between the Member and the Association with respect to any and all use of offerings and services. This Agreement supersedes and replaces all prior or contemporaneous agreements or understandings, written or oral, regarding the Parties' relationship. This Agreement may be executed in counterparts, all of which shall constitute a single agreement. The Agreement shall be effective as of the date set forth on page 1. If any part of this Agreement is determined invalid or unenforceable, the remaining parts shall continue in full force.

### **Confirmation**

You affirm that you are of age, capable of managing your own affairs, and may lawfully consent to and enter into this Agreement, or you enter into this agreement on behalf of your dependent, and that you choose to enter into this agreement of your own free will.
