to the man or woman who sometimes act as public servant:

affirmation and explanation of non-citizen, Ohioan US / state national standing reservation of all rights

i, cristina marni delia, the woman, do state: I do attest that I am borne of my father, an enlisted member of the United States Air Force serving at Fairchild AFB, and my mother, on the land of one of the various states of the American Republic: Washington, in the year of our Lord and Savior, Jesus Christ, 6:45 am, March 1, 1966 at Holy Family Hospital, Spokane;

i do affirm and claim my lawful right to the standing of *non- citizen US national on Ohio* (“Ohioan”); I do attest and affirm that, though borne a Washingtonian, the historic living of I on the land within the geographic metes and bounds commonly known as “Ohio” since the year of our Lord, Jesus Christ, 1988 August, i do thus owe majority lifelong allegiance to said nation state, do embrace and declare my rightful living standing as an Ohioan;

i, do claim, affirm, attest and reiterate that the original Constitution of the United States Republic for America do both imply and clarify that the God-given unalienable rights of the living (wo)man shall not be infringed upon nor diminished; therefore i state: i do not operate nor exist in commerce; i am not now nor ever have i willingly or knowingly consented to diminish or relinquish my rights; i am not now nor have i ever been in contract, treaty nor private lawful agreement with government agencies nor agents as a “US person,” US citizen,” “agent or employee of any government agency – federal, state or local,” nor am I now, nor have I ever been, a member by conscription or voluntary enlistment, in any capacity, to any military or other government service, or any other corporate or legal fiction, nor indeed any other vaguely or specifically construed nomenclature or title, which may in any way diminish my standing from that of a living woman who is borne on the land;

i, do: reserve all rights, at all times, in all places, and circumstances; i, do not consent to being identified as, or under, any monetized alpha or numeric code, whether such code be known commonly as: trust, or bank account, or certificate, or license, or patent, or any

other designator which do produce or enact the fictional diminishment or corporate personification of i, the woman, cristina marni delia (formerly cristina lee henderson, or cristina marni henderson, or cristina marni jurek, or cristina marni henderson-delia) which, when I was but a newborn girl when these alpha numeric codes were created intended to be used to infringe or revoke the God-given unalienable rights of mankind and transmute my living body into a corporate commodity, marketed for trade and or profit by any creature or corporation other than i, myself, I would have objected and fully refused consent as i do herein hereby; i do now both fundamentally and lawfully object to any 'requirement' of use of any of the above described diminishing, commodifying/monetizing alpha numeric identifier codes as condition for exercise of the unalienable rights bestowed upon i by my Creator;

kindly update any and all records in your care to reflect and protect my true standing immediately;

however, though I do not consent to this either, i am certain that you have access to records which show this number of identification of social security numbered account, initiated upon the filing of my certificate of live birth, therefore i reveal no information which you do not already have, save perhaps that I do prove that i am familiar with this number; and, because i am aware of the usual procedures for issuance of certain standardized documents, I do, under duress, and without giving consent to being identified UNDER it, here provide the number:

By submission of this document and those standardized forms to which it is attached, I do express my wish to obtain the standardized identifying documents pertaining to American – Ohioan allegiance in order to freely exercise the unalienable rights of i, the woman, reflecting the legal presence standing of *non-citizen United States national – Ohioan*.

So say i on this 4th day of May in the year of our Lord and Savior Jesus Christ 2026; i am eager to testify to the above affirmation of true fact before a jury of my peers and a competent magistrate in any open court should the need arise.
