exercise of unalienable rights guaranteed under the bill of rights

Article 1, US Constitution

right to private travel - not in commerce

i, the woman, **cristina marni delia**, am beyond the age of majority and of sound mind and peaceful intent; i, a woman living on the land, do here reaffirm my standing as an Ohioan, **non-citizen** US / state national: i, do affirm and attest before God and all mankind through this statement, by rights secured under provisions of the constitution of the united states of America Republic, the constitution of the several states, common law, natural law and Gods laws, that these rights are retained and held and protected with special regard to rights designated and/or set forth as follows: rights and property are one in the same as do say the **Justice LOUIS BRANDIS, U.S. SUPREME COURT;**

i do say, right to travel unimpeded freely is guaranteed and not a mere privilege; that the right to travel is such a *basic* right it does not even need to be mentioned, for it is self-evident of common sense; **see SHAPIRO vs. THOMSON, 394 U.S. 618;**

the right to travel by private conveyance, for private purposes, upon the common way, *cannot be infringed*, no license or permission is required for travel when such travel is not for the purpose of commercial profit or gain on the open roads / highways operating under license in commerce;

the above named common law Ohioan US / State National **does not operate in commerce** and, as such, is thereby **exempted from the requirement of a license**, further, any state, or by or through it's designated agents, is *forbidden by US code* from converting a basic right into a privilege and requiring a license and or a to be fee charged for the exercise of the basic right; **see MURDOCK vs. PENNSYLVANIA, 319 U.S. 105;**

if any state, by or through any of it's local agents, do convert basic rights into 'privileges' and require a license or fee, a US or state national in the private *may ignore the license or fee with total immunity for such exercise of a basic right*, **see SCHUTTLESWORTH V. BIRMINGHAM, ALABAMA, 373 U.S. 262;**

if a non-citizen US or state national exercises a basic right and a law of any state is to the contrary to such exercise of that basic right, the said supposed law of that state **is a fiction under color of law and 100% unconstitutional**, *no courts are bound to uphold it and no US / state national in the private is required to obey such unconstitutional law or requirement*, **see MARBURY v. MADISON, 5 U.S. 137 (1803)**, which has never been overturned in now 223 years, **see Justice Shephard's Citations;**

i have never willingly and knowingly consented into any contract or agreement to relinquish, even temporarily, any constitutional rights; **see Zobel vs. Williams, 457 U.S. 55**, which held the right to travel is constitutionally protected;

i do say any contractual payment for a privilege requires a benefit to be received; since the right to travel is already Constitutionally secured within every of the several states on America, it is clearly unlawful to

cite any charges without direct harm / damage to a specific living man; none may be charged with an offense for the exercise of a constitutional right, in this case the right to travel, **see Miller vs. UNITED STATES 230 F2d 486**, nor may be denied due process of law or equal protection under the law;

i, the woman, cristina marni delia, do hereby declare, claim, and certify any and all constitutional rights inviolate from God and doubly secured in spirit and codified language of the united states constitution, as an Ohioan, US national existing and acting entirely at common law, and retain all basic rights, ucc 1-308, all rights reserved.

i do declare: **any infringement** of God-given rights is a violation and a trespass harm, with remedy due from each man or woman who do such harm, in the form of a remedy compensation for such trespass; the amount of \$10,000 per each instance, due and payable immediately at the moment of trespass, in troy ounces silver coin with the penalty of 1% total amount due accrued daily at midnight until receipt of full payment directly to i, the woman; **any and all orders**, whether direct spoken or implied through manufactured emergency by roadway armed pursuit, being fulfilled by i, are at an agreed upon compensation to i, the woman, of \$50,000 in troy ounces silver coin per instance, due immediately upon fulfillment, with the penalty interest amount of 1% of the total accrued daily at midnight until receipt of full payment directly to i; **any and all violations of code and statute by agents** against i, the woman, shall be at the remedy compensation amount of \$1 Million in troy ounces silver coin per instance, due immediately upon perpetration of said criminal act against i, whether in body, property or reputation, and shall carry a penalty of 10% interest per day accrued at midnight until full relief is paid directly to i, the woman; **see 18 USC 1091; 28 USC 3002 (15); 18 USC 3571; 32 CFR 536.77 (a) (3); 42 USC 1994; 18 USC 242;**

I, the woman, cristina marni delia, have and do declare the standing of i, the living woman, to be a **constitutional national of the United States of America** (09) The term “national of the United States” means a person who, though not a citizen of the United States, owes permanent allegiance to the United States of America Republic. **8 FAM 505.2-10**

i do state and declare the foregoing to be true and complete in perpetuity, under God, before all mankind, on this 4th day of May, in this 2026th year of our Lord, Jesus Christ; i am eager to testify to same before a jury of my peers in front of a competent magistrate in open court if need do arise;
