Quo Warranto in Federal Practice

Definition & Purpose

Quo warranto (Latin: "by what authority") is an ancient common-law writ used to test whether a person may lawfully hold a public or corporate office or franchise. The proceeding asks: by what warrant does this person exercise this office? The primary remedy is ouster — if the defendant is found to lack authority, they are removed from office.

Statutory Framework: 28 U.S.C. §§ 377a–377c

These three sections are the core federal statutes governing quo warranto:

Section Subject

§ 377a Who may bring — The Attorney General or a U.S. Attorney may bring a quo warranto proceeding in the name of the United States. An "interested person" may also proceed by leave of court, acting as a relator on behalf of the United States.

How FRCP 81(a)(4) Interacts

The Federal Rules of Civil Procedure apply to quo warranto proceedings only as a gap-filler:

They apply where practice is not specified in a federal statute (i.e., not in §§ 377a-377c) and

That practice has previously conformed to civil action practice.

In practice, this means the FRCP govern things like discovery, motions, and general procedure where the statutes are silent, but the statutes control on the core questions of who may sue, how the writ is served, and the basic procedural posture.

Standing is restricted: Only the Attorney General, a U.S. Attorney, or a court-approved relator may bring the action. Private parties generally cannot bring quo warranto on their own behalf in federal court.

Burden of proof may shift: The state may charge usurpation in general terms, requiring the defendant to allege and prove their right to the office.

Abatement: If the defendant voluntarily surrenders the challenged office after the proceeding commences, the action typically abates.

No statute of limitations or estoppel: The government is not barred by these doctrines.

Civil, not criminal: A new trial may be granted and an appeal taken under ordinary civil rules. However, the relator may not appeal a judgment in favor of the defendant without the Attorney General's approval.

Quo warranto is rarely used in federal courts. As noted in a 2021 Florida Bar Journal article, the writ's federal use is largely theoretical, and "quo warranto actions in federal courts seem to be governed by the provisions of [the D.C. Code]" (D.C. Code § 23-110) for proceedings in D.C. courts. A more likely modern use would be to challenge the authority of a federal public official to hold office, but even that is uncommon. The writ is far more active in state courts, where state attorneys

general (or, in some states, private relators) use it to challenge public office-holders, unlicensed professionals, and corporate franchises.
